

The State of South Carolina.

In the name of God, Amen. I Aquilla Quick of the District of Marlborough & State aforesaid (planter) being very sick & weak of body, but of perfect mind & memory, thanks be given to God.

Calling unto mind the Mortality of my body & that all men are once to die, do make & publish this my last Will & Testament; & first of all I give & recommend my Soul to Almighty God who gave it, & my body to the earth to be buried in a decent christian burial at the discretion of my Executors.

And as touching such worldly affairs as God in his pleasure has befeſt me with in this life I give devise & dispose of the same in the following manner & form.-----

First, I give & bequeath to my youngest Daughter Anne all that tract or parcel of Land lying on the North side of Crooked Creek containing three hundred Acres (more or leſs) the same being all I pofſeſs on the North Side of Sd. Creek together with half my household furniture & two negro Girls Ella & Maria, and my Stock of Cattle on the said North side Crooked Creek, & two horses & half my stock of hogs.--To my Daughter Mercy I give & bequeath five hundred Acres known by the name of the Cowpens, & the other half of my household furniture, & my two negro Girls Lucy & Hannah, and the stock of Cattle on the above land, & two horses, & the other half of my Hogs.--To my Son Stephen the plantation whereon he now lives containing three hundred Acres,-- To my Nephew Zachariah Quick I bequeath the plantation whereon he lives Containing one hundred Acres,-- and to my own begotten children Judith, Viner, Nancy, Chavis, Charlotte Lockleer and Aquilla Quick, I bequeath one hundred Acres of Land each in the fork of Lightwood Nott & Crooked Creek, to be marked off & divided among them by my Executors, to my Grandson Ledorick, (Aquilla's Son) I give my upper plantation known by "my home place" containing one hundred acres more or leſs, & a negro Girl named Mace, & to my Grandson Tristram (Steven's Son) I give my Negro

boy named Allen.

And to all my other children not mentioned above & to James Quick my Grandchild, I give & bequeath all the remaining part of my property not given or bequeathed above, to be equally divided among them by my Executors & Moreover I appoint my Son Stephen Quick & Thomas Quick my Sole & lawful Executors. And I do hereby utterly Disavow revoke and disannul all and every other testaments, wills, legacies, bequests & Executors, by me before now in any way named, willed, bequeathed or appointed, ratifying & confirming this & only this to be my last will & Testament, --
