In the name of God Amen, I Josiah Evans of the State of South Carolina and County of Marlborough being very sick and weak in body, but thanks be to God of perfect mind and memory & calling to mind the mortality of my body do make and ordain this my last Will and testament, that is to say which in this worldly estate which it has pleased God to blefs me with in this life, I give demise and dispose of the same in the following manner & form.

First. I give and bequeath unto the Baptist church of Christ in the Welsh neck the Sum of three pounds Sterling, to be paid on demand after my Just debts are discharged.

Fourthly. likewise I give and bequeath unto the child with which third my beloved wife is now pregnant with all the remaining part of my real & personal estate if it should be born alive, and arrive if a mala to the age of twenty one years, or of a female to the age of eighteen, or be married, to him or her & his or her heirs forever, But if said child of which my wife is now pregnant should be still born or should die before it arrives to the years aforesaid, then & in that case, the third part bequeathed to it as Just mentioned I give and bequeath to my beloved wife Catherine and my daughter Hannah in the following manner, that is to say,
