Secondly for the Good will and love which I have for my Sister Rachel Windham I give and bequeath unto her my Riding Chair and Gold Watch and five hundred dollars out of my estate.

Thirdly I give and bequeath unto my brother John Whittington five hundred dollars. Also I give unto my brother Nathaniel Whittington five hundred dollars, Also I give unto my brother Levi Whittington ten dollars and To the heirs of my deceased brother Francis Whittington ten dollars and the heirs of my deceased Sister Hannah Blackman ten dollars. Also I give unto my nephew John Windham two hundred Dollars Also I give unto my nephew Levi Windham two hundred dollars Also I give to my nephew Thomas Windham two hundred dollars Also I give unto my niece Elizabeth Marsengile two Hundred dollars also to my niece Rhoda broach two hundred dollars also to my nephew Nathaniel Whittington Lenox two hundred dollars Also to my nephew Gradi Whittington fifty Dollars also to my niece Elizabeth Allison Fifty dollars also to my nephew Francis Whittington Fifty dollars, Also to my niece Jesse Shanks fifty dollars Also to my niece Ann cox fifty dollars Also to my nephew Nathaniel Whittington fifty dollars and to my niece Ann Whittington Fifty dollars and to my nephew James Whittington ten dollars and to my niece Hannah Murphey ten dollars and to my niece Elizabeth Dunnam ten dollars ten dollars to my nephews and nieces the children of my brother Levi Whittington also I give to my niece Martha More the tract of land I now live upon with another tract adjoining to it supposed to be two hundred acres and the

half of my house and kitchen furniture To her her life time  
and at her death to the heirs of her body and if there should  
not be no heirs of her body to Rachel Crawford and to the heirs  
of her body. Also I give to Rachel Crawford three Head of mules  
my Riding horse and my Silver watch and my stock of Cattle and  
the half of my house and kitchen furniture to her her life time  
and at her death to the heirs of her body and for the Justice  
that belongs man to man at my death I do freely deliberate and  
free all my Slaves by giving to them a tract of land known to  
by in the ~~possession~~/ possession Swamp adjoining of the dunnam  
land supposed to be one hundred and fifty acres more or less  
I also give putter one horse mule five head of Cattle and  
twenty dollars to be paid to each one out of my crop and the  
ballance of my crop after my negroes are shod Clothed and  
taxt the ballance of my crop shall return to my Executors  
and Executrix. I do here appoint my brother Nathaniel Whitt-  
ington James Crawford John Windham Rachel Windham- as my Ex-  
ecutors and Executrix of this my Last Will and Testament as  
Witness my Hand & Seal this 4th day of June
