but of Sound mind, calling to remembrance the frailty and
Mortality of my Nature, do in sincerity commit my soul to
God through ~~Jesus~~ Christ in hopes of a happy immortality
and my Body to be buried in a Christian like manner by my
Executors hereafter mentioned my worldly affairs I dispose
of in the manner and form following -----

Inprimis it is my Will that all my Just debts and funeral ex-
penses be fully paid and satisfied. -----

Then I give and devise to my Son James Blair the following
tracts of land one tract containing one hundred and fifty acres
in Darlington County about four miles below the Long Bluff com-
monly called Jacksons place adjoining lands of Thomas Williamson
and the Estate of George Wanderson deceased also one other tract
containing three hundred and thirty acres in Darlington County
aforesaid adjoining lands of Major Pierce Butler for which I
lately obtained a Grante. To have and to hold the said two sev-
eral tracts of land with the appurtenances to him the said James
Blair and to his Heirs and assigns forever. I also give and be-
queath unto the said James Blair and to his Executors adminis-
trators and assigns forever the following negroes viz negro fel-
low named Big Dick negro woman named Peg and her child named
Jack and two negro boys named Jame and Davie I also give and
bequeath to the said James Blair a Mare commonly called bonny
and a horse commonly called Valliant and six head of black
Cattle to be taken out of my Stock Nevertheless it is my Will
and I do hereby direct and order that until the said James
Blair shall attain to his age of twenty one years that the
personal property herein before bequeathed to him shall be and
remain in the hands of my Executors herein after named and the
rents issues and profits thereof to be applied by them to the

Item I give and devise to Wade Mims Blair and to his heirs and assigns forever a tract of land lying and being near Lynches Creek above Thomas's Mills containing two hundred and forty acres. provided nevertheless he claim the same within five years after my death and if the said Wade Mims Blair should not so claim it within five years after my death then and in that case I give and devise the said tract of land to the before mentioned James Blair and to his heirs and assigns forever.

Item I give and devise unto ~~the~~ ^{John} Hall of Charleston Merchant and to Moses Pearson of Pee Dee planter and to the survivor of them the following tracts of Land one tract called the upper plantation containing three hundred acres lying on the Southwardly side of Pee Dee river situate between lands of Joshua Edwards Estate and the William Evans Evans land also a piny woods plantation whereon I formerly lived containing one hundred and ten acres situate in Marlborough County adjoining lands of Jonathan Johns also one tract containing three hundreds Acres in Darlington County directly opposite to the Bluff Tract whereon I now live adjoining lands of William Evans also one tract of land containing three hundred and fifty acres called the lower tract adjoining lands of Major Pierce Butler and also adjoining the last mentioned tract also the Bluff tract whereon I now live containing one hundred and fifty acres also a small tract adjoining the said Bluff tract originally surveyed for John Robertson and in the said survey laid down for sixty six acres also a tracts of Piny woods land adjoining the said Bluff tracts containing two hundred and ninety six acres granted among other lands to Anthony Pouncy also another tract of Piny woods land lying back of Darbys Bay and extending to the long Branch of the three Creeks containing two hundred acres also one moiety of a

containing two hundred acres also my lotte of land in the town of Greenville To have and to hold all and singular the before mentioned tracts of land with the rights members and appurtenances to them the said Colin Campbell and Moses Pearson and to the survivor of them and to his Heirs and assigns forever In trust nevertheless and to and for the sole and separate use benefit and behoof of my dearly beloved daughter Lucia Campbell the wife of Robert Campbell in manner following that is to say in trust to permite my said daughter from time to time and at all times during her present coverture to receive take and enjoy to her sole and separate use notwithstanding the said coverture and without the intervention of her said husband all and singular the rents issues and profits of the said several tracts of Land and every part and parcel thereof with the rights Members and appurtenances and at the dissolution of the said coverture in case she survive her present husband to convey to my said daughter and to her issue by her said husband Robert Campbell by good and effectual conveyances in fee simple all and singular the before mentioned lands and premises and in case my said daughter die before her said husband to convey by good and sufficient conveyances all and singular the before mentioned premises and lands to such person and persons in such parts portions and proportions in such estate and Estates to such use and uses and subject to such charge and charges incumbrance and incumbrances as my said daughter by her laste will and testaments duly executed in the presence of three witnesses shall think proper to order direct and appoint and in case my said daughter should make no such appointment then in further trust to and for the use benefit and behoof of the issue male and female of her by her said husband share and share alike.

Item I give and bequeath unto the aforesaid Colin Campbell and Moses Pearson and to the survivor of them the following negroes viz. Negro fellow named Tom fellow Gork and his wife hannah and her children Maria and Flora fellow little Dick and his wife

subject nevertheless to the before mentioned bequest to James Blair To have and to hold all and singular the negroes horses and cattle herein bequeathed together with their future issue and increase to them the said Colin Campbell and Moses Pearson and to the survivor of them and the Executors and Administrators of such survivor in Trust nevertheless and to and for the sole and separate use benefit and behoof of my aforesaid daughter Lucia Campbell notwithstanding the coverture in the same manner and to the same intents and purposes as well during her life as at and after her death as has been already herein before declared and directed in respect of the lands and tenements herein before devised for her use to which for certainty I refer and I do hereby declare that as well the before mentioned devise of lands as the above bequest of Negroes horses and Cattle to the said Colin Campbell and Moses Pearson in form aforesaid are to be taken received construed and accepted in trust for my said daughter and to be at sole disposal as aforesaid for which purpose and for no other purpose whatsoever I have and by this my last Will and Testament do make ordain and constitute the said Colin Campbell and Moses Pearson Trustees under this my will directing and requiring them and the survivor of them the heirs Executors and administrators of such survivor with all diligence and attention hereto well and strictly to execute perform and maintain the same trusts respectively according to the true intent and meaning of this my will.

Item I give and bequeath to my dearly beloved mother Lucia Blair the sum of Fifty pounds sterling money being the remaining part of a Legacy bequeathed to her by Wade Blair also the further sum. sum of twenty pounds Sterling as a token of filial love and affection

Item All the rest and residue of my real and personal Estate I give and bequeath to my said daughter Lucia Campbell and to her Executors administrators and assigns forever.

Item I do hereby nominate constitute and appoint my son in law Robert Campbell and Moses Pearson Executors of this my laste will and testamente thereby revoking repealing and annulling all former and other wills codicils and testaments by me and made and declaring and pronouncing this and none other to be my last will and testamente in witness whereof I have hereunto sette my hand and seal the twenty second day of November in the year of our Lord one thousand seven hundred and ninety.
