I Robert Purnell of the State of South Carolina and district of Marlborough planter, being weak in body but of sound and disposeing mind memory and understanding praised be God for the same do make this my last Will & Testament in manner and form following, first, my will and desire is that all my just debts of every description be punctually paid as soon as convenient after my decease by my Executors herein after named.

2nd. I give & bequeath unto my beloved son Hinson Purnell one tract or parcel of land lying in the District aforesaid containing one hundred seventy three acres (more or lefs) adjoining to & being part of a Tract Whereon John Purnell now now lives and bounded by lines concluded on, between said Hinson & John Purnell,

3rd. I give & bequeath unto my beloved son John Purnell one tract of land Whereon he now lives containing one hundred and Seventy three acres (more or lefs) bounded by concluded lines between the said John & Hinson Purnell & Also a parcel of Gattle which he now has in his possession.

4th. I give and bequeath unto each of my beloved daughters Mary Conner & Hariat Bounds or their heirs & afsigns each the Sum of Two Hundred Dollars to be raised out of the sale of my..... Robt. Purnell

personal Estate hire of Negroes &c to be paid by my Executors at their discretion, in manner which they may conceive to be mostly to their benefit.

5th. I give and bequeath unto my beloved daughters Dorcas Newton & Miranda Bridges their heirs & afsigns each the sum of three hundred Dollars out of the Sales of my personal Estate.

hire of Negroes &c to be paid by my Executors as soon as convenient after my decease & as soon as the same can be raised by the above mentioned means.

6th. I give and bequeath unto my beloved daughter Ann Dyke Purnell one Neg girl, girl Inda to be hers with the Increase of said girl if any her heirs and assigns forever, and one ~~another~~ bed & furniture and the Sum of Two hundred Dollars to be raised out of my personal Estate the ~~hires~~ hire of Negroes &c & to be paid by my Executors as soon as she shall arrive at lawful age or marry. But if in case she shall die without issue then Her legacy in portion shall revert to her living Brothers & sisters to be divided equally among them or their heirs share and share alike..

7th. I give and bequeath unto my three sons,, James Jenkins Purnell, Hope Hull Purnell, & Robert Purnell All my Lands including the plantation whereon I now live containing in the several Tracts or parts of Tracts about four hundred & fifty acres (more or less) to be Equally divided between them three,, Share & share alike by my Executors and three disinterested persons to be chosen in order to make said Division as Just & equal as possible,, but the division not to take place until my son Hope Hull Purnell shall arrive to lawful age,, then to be divided as aforesaid unless any of them shall die before the age of Twenty one years or without lawful issue in which case their part of share shall revert to the surviving one or two to be divided Equally share & share alike.,

8th.. I give and bequeath unto my son Hinson Purnell the sum of Fifty Dollars to be raised out of the Sales of my personal Estate to hire of Negroes &c.,

9th.. It is my will & desire that my plantation be rented for the purpose of raising money to assist in paying legacies &c in the following manner that is one half to be cultivated one year & the Remainder the next year In order that the land

& plantation may be kept up, until James J. Purnell arrives
at age & at that time

If he shall desire to take charge of the plantation & Cultivate and keep it in repair until my said son Hope Hull Purnell shall arrive at age, at which time the Division among them is to take place..

10th. It is also my desire that my three Negroes viz., Hubb Bill & Jefs be hired out for the purpose of raising money in addition to the proceeds of the real Estate to be Sold, for paying the legacies above mentioned,, after which their hire is to be applied to the use of my two sons Robert Purnell and Hope Hull Purnell for their Support & Education &c until my youngest son comes of age,, the said Negroes to be hired where they will be well treated, and not to go on the River.

11. It is also my desire that my Negro girl Aggy be sold & the proceeds after the above legacies are all paid be divided equally among all my heirs, unless my daughter Dorcas Newton & Miranda Bridges will agree for to draw for her and whoever draws her to pay the rest their respective share.,

12th. I give unto my son James Jenkins Purnell my Negro boy Hubb after my youngest son comes of age to him & his heirs forever,

13. I give unto my son Hope Hull Purnell one boy

named Jefes to be his his heirs & assigns forever.,

14. I give & bequeath unto my son Robert Purnell one Negro Boy Bill to be his & his heirs & assigns forever. But in case any of my said three sons shall die without lawful issue,, then shall/die the said Negroes or any part of personal Estate to which they are Entitled shall revert to my living children to be divided Equally share & share alike.,

15. It is my desire that as soon as convenient after my decease my plantation be rented in manner above mentioned & the negroes hired as above mentioned and that all my personal property not heretofore disposed of to be sold to the best advantage, and after paying all my Just debts and the legacies above mentioned & Educating & Supporting My Children as may seem Just & suitable to their situation in life,, when my son Hope Hull Purnell shall arrive at the age of Twenty one years to be Equally divided among my Children share and share alike.

It is my Will & desire that my son James do take his negro Hubb. into pofession as soon as his hire of the Negroes with the Sale of the personal Estate shall be sufficient to pay all the legacies, above mentioned,

and that my sons Robert & Hope each take pofession of their respective Negroes Bill & Jefee when they arrive at the age of Twenty one years.,

Lastly I constitute nominate and appoint my son Hinson Purnell & my son in law Cornelius Newton Executors to this my last Will and Testament,, this Seventeenth day of August 1824

Testament in manner and form following,, that isto say that as soon as convenient after my decease my Executorm cause my negro girl Abby mentioned in the eleventh clause of said will to be valued by three good men and that my son in law James Bridges and my daughter Miranda Bridges do take the said girl at her valuation if they shall choose to do so and pay over her value except the legacy above mentioned to the other heirs but if in case they shall not choose to take her, that she be sold to the best advantage for the purpose of raising money to pay the legacies &c
