Caldwell the guardian of the persons & estates of my three children & in case of his death or declining of the appointment, I desire that Judge O^c- Neal should be their guardian, & in case of his death or declin- ing of the appointment I do hereby authorize & empower James J. Caldwell to appoint any person whom he shall select as the guardian of my three children, & such person as he may so se- lect I do hereby appoint the guardian of their persons & es- tates as fully as if the person were here named.
