I give and bequeath to my daughter Laodicia Myers during her life, the balance of my personal estate consisting of one mare Kitt and her colt, one mare suse, ~~one small~~ one small waggon and harness, one young cow, music. clock case, nine sheep, and some Kitchen furniture and every other article or thing of which I am possessed, after so much having been sold by my Executor as will pay all my just debts and funeral expenses, and after the death of my daughter Laodicia Myers to her issue forever.

I likewise give and bequeath to my daughter Laodicia Myers for her sole and separate use during her life, the plantation or tract of land whereon I now live containing one hundred and thirty eight acres more or less bounded by lands of Daniel T. Cureton and others and after her death to her issue forever
