In the name of God — amen — I Thomas Reese Clergyman
 of Pendleton County, in the State of South Carolina, being in a
 very weak and low state of body, but of sound mind & perfect
 memory, do make and ordain this my last Will & Testament.
 Firstly & principally, I commit my soul to God, who gave it, as
 into the hands of a faithful Creator, and my flesh shall go
 to the dust, when it is taken, to be buried at the will of my Execu-
 tors in a decent Christian manner; in humble hope of a Resurrec-
 tion to eternal Life, through the Merits & Attonments of my blessed
 Redeemer — And it is my will that ^{no} spirituous liquor be used at my
 Funeral; but lest that should be thought to proceed from a covetous
 temper, my Executors are hereby directed, to take as much money out
 of my estate as they suppose might have been sufficient for the purchase
 of said liquor, and bestow on those whom they deem real Objects of
 Charity — And as to those worldly Goods, with which God, in his Goodness

And be it further shewed, that my will that they be disposed of in the following manner and manner

Item. To my dear faithful and dearly beloved ^{wife} Jane Russ, I give and devise unto her and her heirs and assigns one wench named Rose, & Girl named Hannah, to be hers during her life, & to be disposed of at her death as she may think fit. Also one third of that part of my land which lies in the North side of twenty three mile creek, adjoining her Widowhood, which third shall include my present dwelling house and a twenty a cret at least of cleared land. It is moreover my will, that she have the use & remain in the quiet possession of all that part of my Land which lies upon the North side of Little Creek and of the buildings there on, and also the plantation Tools & Utensils, the Household furniture and live stock of every kind, for the space of ten years; provided she continues unmarried so long, but never the less, she shall be obliged to give off from the Household furniture and live stock such shares to my Daughters at such time and in such manner as herein shall afterwards be directed

Item. To my beloved son Edwin, I bequeath one Negro Fellow named Dony, on condition that he suffer him to remain on the plantation with his mother five years in order to assist in maintaining the young Negroes, also Eighty dollars in Money for the purchasing a Riding horse. The one fourth part of my books and my Manuscripts and my ~~Gold~~ watch.

Item. To my beloved son ~~William~~ Thomas Sidney, I bequeath one Negro das named Jack, on condition that he suffer him to remain on the plantation with his mother five years to assist in raising the young Negroes, also one young ^{bay} horse which he commonly rides, the one fourth part of my books and my Gold Buttons.

Item To my beloved son Ebenezer Harris, I bequeath one Negro Fellow named Sam. on Condition that he suffer him to remain on the plantation for five years to assist in providing for the young Negroes - Also Eighty Dollars in Money, for the purchasing a riding horse, the one fourth part of my books, and my silver Spoons

Item - To my beloved Daughter Leah, I bequeath one Negro Fellow named Cesar, one Child named Cijax, one wench named Cofa, and one Girl named Maria, with their Offspring - also one

fifth part of the stock of horned Cattle and of Sheep and of
~~the~~ Furniture to be delivered to her on her Marriage,
or when she comes of age, if she requires it. — also one
feather bed and furniture, to be delivered at the same time. —

Item. To my beloved Daughter Sophia, I bequeath one Negro
Girl named Mary and one named Mary with their Offspring,
Also the one fifth part of the stock of horned Cattle and of Sheep
and one feather bed and Furniture to be delivered to her on her
Marriage, or when she comes of age, if she requires it. —

Item — To my beloved Son Henry Dobson. I bequeath one
Negro Boy named Cyrus, one Negro boy named Tony & one
negro Girl named Daphne with her Offspring; also a fifth
part of my Books, and my Silver Buckle. It is moreover my
will, that after having received a good English Education, he
be bound out as an apprentice to such Trade or Mechanical
Profession as my executors may think him best adapted
for — to such Master as they shall choose. —

Item — To my beloved daughter Susannah, I bequeath
one negro ~~boy~~ named Prince and one negro Girl named
Chloe with her Offspring — also one fifth of the stock of hor-
ned cattle and of the Sheep, and one feather bed and
Furniture to be delivered to her on her marriage or
when she comes of age if she require it. —

Item — To my beloved Sons Sidney and Dobson. I be-
queath the whole of my Land which lies on the North side
of the Twenty three mile Creek, to be equally divided be-
tween them — That part of my Land which lies on the south
side of P. Creek where Caleb Williams used to live. I will
to be sold as soon as possible, and the Money there arising
to be applied to the discharging of my Debts. —

Item — It is my Will that the two following Negroes, namely one
young Fellow named Gato, and one little Girl named Candis,
be sold, also my Stage Waggon, & that the money arising
from these sales, be applied to the ~~payment~~ payment of my Debts —
and discharging the sums herein ordered to be paid to my
Sons Edwin & Elisha Harris — and the Schooling of my son
Henry Dobson. It is moreover my will that all Monies due

known by hand note or subscription, be applied to the same purpose - page 1

Item - It is my Will that if any of my sons die under age and without issue that his part be equally divided among all the other Daughters, and if any of my Daughters die under age and without issue, that her part be equally divided among all the other Sons.

Lastly - I do appoint my wife Jane Reese my Executrix and Messrs. Ezechiel Pickens, George Reese, John Barnes of Connorop, and Nathaniel Cannon to carry this will into Execution - hereby disannulling any other will or Wills by me written or made, and ratifying and declaring this and this alone my last true last Will and Testament. - In Testimony whereof I have hereunto set my name and affixed my seal this twenty eighth day of April in the year of our Lord One thousand Seven hundred and Ninety six and of the Independence of the United States of America the Twentieth.
