 Item, I give and bequeath to my Daughter Nancy a Negroe girl named Lucy, one
 bed & furniture, second choice, one walnut chest, saddle & bridle & spinning Wheel,
 Item, I give and bequeath to my Daughter Elizabeth a Negroe girl name
 Minda, one bed & furniture and one spinning Wheel. — Item I give and
 bequeath to my Son John one half of my Plantations on Long cane namely the West side
 Item, I give and bequeath to my Son James one half of my Plantations on Long cane nearly the East side
 Item, I give & bequeath to my Son Robert Brown twenty pounds sterling. — Item, I give &
 bequeath to my Son Exelil one half of my Plantations on Rocky river. — Item, I give &
 bequeath to my Son Jesse the other half of my Plantations on Rocky river, and the Negroe man
 named Bob, and Negroe Woman named Charlotte is to be equally divided between my two
 youngest Sons, at their Mothers death, — Item I give & allow two cows & calves, to build a chime
 murr of the best a quantity. Item I will and allow that my effects (viz), horses, cows, &
 stocks of all kinds, Plantation tools, and all manner of household furniture, with what
 was else belongs, or appertains to my estate, not herein before mentioned & bequeathed
 be sold at Public vendue, and the Money arising from thence, Together with the
 debts due to me, be equally divided among all my Children. — and I hereby
 do hereby make ordain constitute and appoint my trusty & well beloved Brethren
 Patrick Norris & Charles M. Clevor & James Thompson to be the executors of this
 my last will and Testament, and to put the same in execution according to the true
 intent and meaning hereof, and I do hereby revoke make void disannul all
 other Testaments and wills by me at any time heretofore made, establishing this
 and none else to be my last will & only Testament, signed with my hand and
 sealed this tenth day of January, one thousand seven hundred and Ninety seven
 and of the Independent States of North America the Twentieth first. —
 We whose names are under written did in the said
 John Norris sign seal, & acknowledge this, as his last will
 & Testament declare the same, as witness our hands, this
 tenth day of January 1797 —

 being very sick and weak in body but of perfect mind and memory, thanks be given unto God, call-
 ing unto mind the mortality of my body, and knowing that it is appointed for all men once to
 die, do make constitute and ordain this my last will and Testament, that is to say, Principally first
 of all I give, and recommend my Soul into the hands of almighty God, which gave it me, my last
 and I recommena to the Earth to be buried in Decent christian burial at the discretion of my
 Executors, nothing doubting, but at the general resurrection I shall receive the same again by
 the Mighty Power of God, and as touching such worldly Estate as it has pleased God, to bless
 me in this life with, I give assign & dispose of the same in following manner & form,
 First of all, I will that all my just & lawful debts be paid out of my estate, funeral expenses &c. —

2^d The Mannes, Plantation or Tract of land whereon I now live, I will that it shall
belong unto my beloved wife Hannah Brown, during her life or till she pleases to
give it up, and then that it shall devolve & belong to William Brown, Son of
Alexander Brown, — god I will that my beloved wife Hannah Brown
(whom I constitute & appoint to be my executrix) shall peaceably possess all the Negroes
which I am now possessed of, during her life; and at her decease that she shall dis-
pose of them as she sees cause. — 4th I also will that my beloved wife Hannah
Brown shall also possess all my household goods & valuable effects, For other
disallow, revoke & disannul all and every other will or Testament made by me
to be Null, void & of none effect; and that this & no others, be my last will & Tes-
tament made this thirty first day of August Anno Domini, One thousand seven-
hundred and Ninety two and in the seventeenth year of the sovereignty & imperi-
um of the United States of America —

South Carolina being very sick and weak in body but of perfect mind and memory
thanks be to God, calling unto mine the eternity of my body I do make this my last
will & Testament, that is to say principally and first of all I give and recommend my
soul into the hand of Almighty God that gave it and in whom I trust I served in my poor
weak way in the preaching of the Gospel from my youth up till now, and my body I recom-
mend to Earth in full and certain assurance of a Glorious Resurrection & eternal life
and Fellowship with my God, Saints, & Angels; And as touching such worldly
Estate wherewith it has pleased God, to bless me with in this life, my will is
first that my body be buried in a Christian decent manner at the discretion
of my executors — Secondly that all my just & lawful debts, shall be paid out,
of my little estate. — Thirdly, that all that estate that was devised to me by John Falkner, as
may be seen on the records in Laurens County office, if ever it is obtained shall be equally
divided among all my children — likewise one Negro woman named Abby, & her Daugh-
ter Jenny which is of my own property I give unto my beloved wife Elizabeth, to be hers dur-
ing her natural life time and after her decease to be equally divided among all my chil-
dren, and do is my will that none of the above property shall be sold out of the Family —
Likewise my will is, that my lands shall be my beloved wife, during her natural
Life time: except one soverl call known by the name of craps-cott, which I give unto
my son Nathaniel; likewise my will is that if any other boys stay with their Mother
untill they are twenty years of age, then she shall furnish them with suitable young crea-
tures as the stock will afford at that time, also a good country made saddle & bridle, likewise
my will is that all my personal, real & moveable property shall be equally divided among
my children after her decease, — And I do hereby utterly disallow, revoke & disannul
all & every other former Testaments, wills, legacies bequeaths &c, by me in any wise before
