

IN THE NAME OF GOD, AMEN:

I, Andrew Ferguson of the State of South Carolina and District

and recollecting that I am born to die - I do this 28th day of April 1843 make and publish this my last will and testament in manner following - that is to say -

First, I will to my wife Mary the plantation goods and chattels where I now live during her natural life and from and after her decease then the land goods and chattels to be sold on a credit of twelve months except the land which will be a credit of two years - I give and devise the moneys arising from said sales to be equally divided amongst my children the legatees of sd. estate.

Secondly, I will and bequeath to Sarah Ann Morehead one cow and cradle and one bed and furniture as her portion when she arrives to the age of eighteen years and I also bequeath to her five dollars to be laid out in some store for dressing of her such as the executors thinks best she needs - I also wish and devise that one hundred and fifty acres of land along the conditional line betwixt Ferguson and Jarratt beginning at James Fergusons corner and running with his line a north course to it makes 150 acres be sold for money and the money arising from said land to go to pay all just debts and if not enough to sell a yoke of oxen and cart a rifle gun and cows to all debts is paid - I also wish the Executors to rent said place and the rent to go to support my wife and family with Sarah Ann Morehead unto 18 years of age.

And I make and ordain Thomas Farmer of Georgia and Franklin County and James Ferguson of this State and District, Executors of this my last will and testament in trust for the intent and purposes there in my will contained and to take care and to see the same performed according to my true intent and meaning.
