

IN THE NAME OF GOD, AMEN:

Calling to mind the uncertainty of life and being of sound mind
and disposing memory, I do hereby make and ordain this my last will
and testament in form following. Viz -

ITEM 1st. It is my will and desire that all my just debts shall
be paid and for this purpose I set apart all the debts that are now
due me in the hands of my Executors to apply to the same and if there
should be anything still behind unpaid my Executors to sell the fol-
lowing property, Viz - two yoke of oxen one ox cart and other articles
that can be spared by my family, viz - the present crop which is now
making and what is made at the saw mill out of which my son Francis
H. Cleveland to receive fifty dollars for his services in attending
to the same.

ITEM 2nd. It is my will and desire that my beloved wife have all
that tract of land known by the name of the Wright tract commencing
on a red oak Lowery's line following the old road to the fence corner th
thence the line until it strikes the upper corner of the burn
field thence to the top of the ridge thence to the dividing ridge to-
wards the Sloan Ferry road from Hunts - for the use of her and the
smaller children until the youngest child becomes of age and in case
my wife Mary Cleveland should marry before that time then for her to
receive a child's part and give up the land to my Executors herein-
after named to be sold by them and the money equally divided among
my children.

ITEM 3rd. It is my will and desire that my daughter Sarah Sanders
receive one hundred and seventy-five dollars as I have heretofore
paid her twenty-five dollars to be paid to her by my Executors as soon
as they conveniently can after they have paid my just debts.

ITEM 4th. It is my will and desire that my son Jonothan Cleveland
have the tract of land on which he now lives for two hundred dollars
as he has heretofore paid one hundred dollars for the same.

ITEM 5th. It is my will and desire that my son William Cleveland
be paid by my Executors as soon as they can after paying my just debts

two hundred dollars.

ITEM 6th. It is my will and desire that my son Francis Cleveland have two hundred dollars when he becomes of age.

ITEM 7th. It is my will and desire that my daughter A. M. Cleveland have two hundred dollars when she becomes of age.

ITEM 8th. It is my will and desire that my daughter Elizabeth Cleveland be paid two hundred dollars when she becomes of age.

ITEM 9th. It is my will and desire that my daughter Corinth Cleveland be paid two hundred dollars when she becomes of age.

ITEM 10th. It is my will and desire that my son E. H. Cleveland have two hundred dollars when he becomes of age.

ITEM 11th. It is my will and desire that my son Jerry Cleveland have two hundred dollars when he becomes of age.

ITEM 12th. It is my will and desire that my daughter Harriet Cleveland have two hundred dollars when she becomes of age.

ITEM 13th. It is my will and desire that the tract of land known as the Cox tract part of Johnson tract part of Jarvis tract Home tract Duch tract including part of the Wright tract from the ford of the branch running with the Pickens road to bowrys line and the Mill tract to be disposed of by my Executors hereinafter named in the following manner, Viz - to sell any or all the above named tracts of land at such times as they may be able to obtain a fair price for the same, the money or moneys arising from the same to be applied to the payment of my children as they become of age or if the lands are not sold at fair prices then to be rented out.

Therefore, reposing special trust and confidence in my two sons Jonathan and William I nominate and constitute and appoint them my true and lawful Executors to carry out this my last Will and Testament.
