I, Henry McDonald of the State and District aforesaid, being of sound and disposing mind and memory, and calling to mind the uncertainty of life do make and ordain this my last Will and Testament, that is to say: as regarding such worldly estate as it hath pleased God to bless me with, I give, devise and dispose of in manner following:

I desire that immediately after my decease, my son Henry Duff McDonald shall pay all my just debts and funeral expenses; after my just debts and funeral expenses shall have been paid, I give and bequeath to my wife Susan McDonald all the residue of my estate, during her natural lifetime, to be owned occupied and enjoyed by her as her own right and property, at the same time I desire that my son Henry Duff McDonald remain on the premises as he heretofore has done and that he shall aid and assist in the proper management of the farm and affairs thereof, and to the ease and comfort of his mother, and that he receive whatsoever amount as an equivalent for his services, as he and his mother Susan McDonald may see proper to agree upon. I also desire that immediately after the decease of my wife Susan McDonald, my son Henry Duff McDonald, whom I constitute make and ordain my only and sole executor of this my last will and testament, that after he pays all funeral expenses occasioned by the burial of his mother, that he the said Henry Duff McDonald shall then be only and sole heir and proprietor of all lands, tenements, stocks, goods, chattels, houses and household furniture and of every part of my estate, both real and personal which I have not previously disposed of (that previous to my decease) I leave and bequeath to my daughter Selena Shoyers (formerly Selena McDonald) One dollar, she having already received from me the portion of my worldly estate which I designed for her. (Notwithstanding from my parental love and affection towards my daughter Selena, I desire that my Executor and son Henry Duff McDonald shall maintain

comfortably his sister Selena, above mentioned, during her natural lifetime, or that he pay to her the above named Selena (if she would prefer it) the sum of Twenty five dollars annually of good and lawful money, and in case of a noncompliance of either of the above, it is my desire that ... the said Selena recover the amount of twenty five dollars as above mentioned annually, to be obtained from the property which he the said Henry D. McDonald shall have become in possession of, after the decease of his mother Susan McDonald, as hereinbefore mentioned.

And I do hereby utterly Disallow, Revoke and Disannul all and every other former Testaments, Wills and Legacies, Bequests and Executors, by me in any wise before this time named, willed and bequeathed.

Ratifying and confirming this and no other to be my last will and testament. In witness whereof I have hereunto set my hand and seal this this thirty first day of August in the year of our Lord one thousand eight hundred and forty six and the seventieth of American Independence.
