

KNOW ALL MEN BY THESE PRESENTS that I, Samuel Addis of Pickens District, South Carolina, being in feeble health and sound mind and memory do make and publish this my last will and testament, hereby revoking all ~~my~~ wills by me at any time heretofore made.

~~First~~ I hereby constitute and appoint H. R. Gaston to be sole Executor of this my last will, directing my said Executor to pay all my just debts and funeral expenses, and the legacies hereinafter given out of my estate.

Second, To my son William John Addis one tract of land lying on the west end of my land commencing at a pine x 3 x 3 0, thence S.64 W.20.65 to a rock x3 thence S.84 W.12 to P.O. x 3 x 3 thence S.78 1/2 W.11.75 to P.O. x 3 x 3 thence S.16 E.22.50 to S.O. x 3 x 3 thence N.78 E.12 to pine stake x 3 x 3 thence S.1.9 E.6.50 to R.O. per stake x3 thence N.78 E.17 to Maple x3n thence a straight line beginning pine corner (which will be more fully shown by referring to a plat made by Wm. Hunt, D. S.) containing one hundred and fifty acres more or less, adjoining lands of G. W. Phillips, Robert Stuckey and others, also one good horse, saddle and bridle.

Third, All the balance of my personal and real property estate I give to my beloved wife Eunice Addis the term of her natural life (or widowhood) and after her death (or marriage) to be divided as follows to my daughters Eliza Addis, Susan Addis, Anna T. Addis and my son William J. Addis, each of them, one bed and furniture, one cow and calf, one spinning wheel and cards, one chest, and one hog valued at three dollars, they are to have the above things or their value in cash, to make them equal with my other children, who have married and received the amount above mentioned.

Fourth, All the balance of my estate real and personal to be sold and the proceeds of sale to be divided equally among all my children or their heirs, to-wit, Eliza Addis, Miriam Milford, Lucinda Clink-Scalles, Hester E. Cole, Harriett M. Brown, Susan Addis, Anna T. Addis and William John Addis, share and share alike.
