

LAST WILL AND TESTAMENT OF THOS. W. HARBIN.

I, Thos. W. Harbin, of the State of South Carolina and of Pickens District, do make, ordain and declare this instrument to be my last Will and Testament.

ITEM 1st. I will and desire that all my just debts be speedily and punctually paid as soon after my death as circumstances will permit.

ITEM 2nd. I will and bequeath that a certain tract or parcel of land known as the Cross Road tract containing two hundred and seventy-two acres be sold at private sale and the proceeds hereof applied to payin my just debts.

ITEM 3rd. I will and bequeath that a portion of the tract of land whereon I now live East of a straight line running from a black gum corner to a black oak corner nearest the branch designated in the of said land be sold at private sale and as much of the proceeds arising from the sale of said land as nine hundred dollars be set apart as a legacy for my sister Polly Harbin and to remain in the hands of my Executors and the interest thereof to be applied by them to her support and maintenance and at her death to be equally divided between my children Henry P. Chandler and Morgan Harbins children in proportion to the time she stays with each and the balance of the proceeds if any of the aforesaid tract of land be applied to the payment of my just debts as aforesaid, if any should remain unpaid.

ITEM 4th. I will and bequeath that the remainder of the aforesaid tract of land on which I live and a negro man named Ned and a negro woman named Millie and the stock of horses, hogs and cattle the wagons farming utensils household and kitchen furniture corn fodder & provisions &c. be set apart for the support raising and maintaining of my minor children subject to the control of my Executors to be disposed of either in whole or in part as their judgment may direct to promote the best interest of all my children and when the youngest child becomes of age to be equally divided among them.

ITEM 5th. I will and bequeath to my beloved son Wiley R. Harbin a certain negro boy named Isaac, and the horse bridle & saddle which he now has and a bed and furniture.

ITEM 6th. I will and bequeath to my beloved daughter Sarah C. Harbin, a negro girl named Martha and a bed and furniture.

ITEM 7th. I will and bequeath to my beloved son Samuel V. Harbin, a negro boy named Clark and a horse bridle and saddle and a bed and furniture.

ITEM 8th. I will and bequeath to my beloved daughter Mary E. Harbin, a negro girl named Mariah and a bed and furniture.

ITEM 9th. I will and bequeath to my beloved son John M. Harbin, a negro girl named Eliza and a horse bridle and saddle and a bed and furniture.

ITEM 10th. I will and bequeath to my beloved son Andrew P. Harbin, a negro boy named Andrew, a horse saddle and bridle and a bed and furniture.

ITEM 11th. I will and bequeath to my beloved son Elias N. Harbin, a negro boy named Arch, and horse, saddle and bridle and a bed and furniture.

ITEM 12th. I will and bequeath to my beloved daughter Harriet R. Harbin a negro girl Carry and a bed and furniture.

Item 13th. I will and bequeath all my unbequeathed estate both personal and real to be sold and equally divided among my aforesaid children provided if nevertheless that any of the negroes bequeathed to the minor children should die before the said minors becomes of age that the value thereof be made good to such minor or minors at a final settlement by my Executors.

ITEM 14th. And lastly I do hereby nominate and appoint Wiley R. Harbin, Morgan Harbin and Henry F. Chandler my sole Executors to carry into effect this my last Will and Testament.
