First, after all my lawful and just debts are paid and discharged, the residue of my estate real and personal, I give, bequeath and dispose of as follows, to-wit: To my beloved wife, Mary Barrett, the land I now live on lying in the State and District aforesaid, on a prong of Georges Creek waters of Saluda River and bounded by lands belonging to Mrs. Melinda Archer, William King and others, containing one hundred acres more or less, with all the apertainances thereunto belonging, together with one bay horse, five head of cattle, eight head of hogs, a one-horse wagon and harness, all of my farming utensils consisting of plow stocks & contents, gears, &c., all of my household and kitchen furniture consisting of beds, steds & furniture, tables, cubards, looks & contents, cooking utensials, earthenware, knives & forks & axes, the present growing crop, all of my notes and accounts to go towards the payment of my debts and the remainder thereof, if any, to my wife likewise. Out of the foregoing named property my three daughters, viz, Mary A. Barrett, Sarah Jane Barrett and Melinda Barrett is to have each one bed and one cow to make them equal with my two elder daughters, viz, Lucretia Carolina McMahan, Rebeccah Eve-line McCoy. All the remainder of the foregoing named property both real and personal is to belong to my wife Mary Barrett during her life after which the remainder thereof shall be sold and the proceeds thereof to be equally divided between each of my lawful heirs, share and share alike, viz, Lucretia C. McMahan, Milton Barrett, Rebeccah E. McCoy, Benjamin C. Barrett, William L. Barrett, Mary A. Barrett, Sarah J. Barrett, Mollinda P. Barrett & John H. Barrett. Here revoking all former wills by me made.
