ITEM 4th. I will and bequeath unto the child or children of my daughter Nancy Blassingame (now deceased) former wife of Robert Blasingame, one eighth part of my estate real and personal.

ITEM 5th. I will and bequeath unto my daughter Mary Blassingames (now deceased) children one eighth part of my estate real & personal.

ITEM 6. I will and bequeath unto my daughter Rebecca Dillard Five dollars in full as her portion of my estate, as I have already given her a tract of land whereon she now lives.

ITEM 7th. I will and bequeath unto my son Robert Bowen one-eighth part of my estate real and personal.

ITEM 8th. I will and bequeath unto my son Thomas Bowen one-eighth part of my estate real and personal.

ITEM 9th. I will and bequeath unto my son William Bowen one-eighth part of my estate real and personal.

ITEM 10th. I will and bequeath unto my son John Bowen one-eighth part of my estate real and personal.

ITEM 11th. I will and bequeath unto my daughter Martha Welborn wife of Joel E. Welborn five dollars as her full share of my estate as I have already given her husband a considerable amount.

I do hereby nominate, constitute and appoint my son Robert Bowen and my esteemed friend John Bowen Executors of this my last will and testament.
