

IN THE NAME OF GOD, AMEN:

I, William Robinson, a farmer of the District of Pickens and State aforesaid, being feeble in body, but of sound and disposing mind and do make and declare this to be my last Will and Testament, and

1st. I give my soul to Almighty God resting in the merits and atonement of my Lord and Saviour Jesus Christ for a resurrection of my body and eternal life in Heaven.

2nd. Let my body be decently buried and my estate charged therefor.

3rd. It is my will that all my honest debts should be paid.

4th. I give to my children by my first wife - each the sum of one dollar; not in a spirit of unkindness but in great affection and from a sense of duty, resulting from reflection that all my said children by my first wife are of mature age and able to support themselves whilst those of my present wife, through whom the property I now possess has been chiefly derived, are young and comparatively helpless, requiring all my limited means for their nurture and education and the due support of their mother and themselves. And,

5th. I give and bequeath unto my beloved wife Elizabeth E. Robinson, and to my dear children by her (to-wit) to my daughter Elizabeth Robinson, to my son Robert Robinson, to my son James Boyd Robinson, to my daughter Josephine G. Robinson, to my daughter Margaret Robinson, to my daughter Victoria Robinson and to any other child or children which my said wife Elizabeth E. Robinson may have or bear before my death or within a competent time afterwards, all my remaining property of every kind and description whatsoever, to-wit, The tract of land on which I now live, it being bounded by lands hereunto belonging to Robert Maxwell, Jr., James L. Boyd and others, in fee simple. Also my bay mare and her mule colt. All my stock of cattle and hogs, all my farming utensils of every kind, all my household and kitchen furniture of every kind and description. Also all

my beds and bedding, and everything else which I now have or may die possessed of, be it real, personal or mixed, to have and to hold the same to them and their heirs forever, with the following conditions and limitations, that is to say -

It is my will that my said wife Elizabeth E. Robinson shall retain and have the management of all the property conveyed by this instrument until her youngest child by me is of age, or until my said wife Elizabeth E. Robinson marries again, and on the happening of either event it is my will that all the property herein conveyed be sold, and that the proceeds be equally divided between my said wife Elizabeth E. and her children by me as hereinbefore designated, share and share alike.

Signed, sealed, published and declared as my last Will and Testament this the 18th day of November in the year of our Lord one thousand eight hundred and eighty-eight.
