WHEREAS, I, William Sanders of the State and District aforesaid being of sound mind and disposing memory and considering the uncertainty of life do make publish and declare this to be my last will and testament -

ITEM 1st. I give my soul to God from whence it came.

ITEM 2nd. I desire my Executors to see after my death as possible to pay all my just debts together with funeral expenses out of the first monies that may come into their hands.

3rd. I give and bequeath unto my loving children all my real and personal estate to be equally divided between them, share and share alike, the heirs of my deceased children taking the share to which their parents would be entitled to, if living.

4th. I have given to my three sons James, David and Wm. B. Sanders, each a tract of land and as I have not given to my daughters the same amount, I desire my sons to account to my Executors & pay each fifty dollars they having received that amount more than my daughters.

5th. I desire my Executors to sell all my property on such terms as they may think best, either at private or public sale & execute titles for the same.

6th. It is my desire that my daughter Mary Ann (Blind & Idiotic) do live with my daughter Elizabeth Hembree, so long as she may live and I desire my Executors to retain in their hands the share due to Mary Ann and pay to Elizabeth Hembree for the support care and attention to her, as they may think she may be entitled to receive it & the remainder to be kept at interest until the whole amount shall be used by her.

7th. I desire my Executors to retain in their hands the amount due to my grandchildren and put the same at interest & account to them with interest as they may arrive at full age.

8th. I do nominate and appoint my two sons, James O. & David

Sanders Executors to this my last will and testament.
