That I Alexander Macdonald am sick and expect to dy. but am in my sound mind & senses after commanding my sole to almighty God through the merits of the Lord & saviour Jesus Christ and my Body to be deacently buried at the discretion of my Executors I do make & ordain this my last will & Testament----- Item after my funeral charges & all my just debts are paid, I will that all my property ~~as~~ real & personal be Kept to geather for the use of supporting raising & schooling my beloved Children, until my Youngest Child Maryan comes of age then to be equally divided among all the surviving heirs of my Body legally begotten by me-- Except my Beloved Daughter now Catharine Rayford to whom I have already given which she has or has had in possession a negro woman named Hannah & a Boy named Tom which said two negroes I will that they be apraised what they was worth when I gave them into her possession & the amount to be a part of her Legase at the time of the devisiion. Item I will that if either of my Children dy before the devisiion of my Estate takes place leaving a lawfull Eshue that or they shall inherit thier fahthers or Mothers part-- Item I will & autherisse my hereafter named Executors if they think best to do so for the benefit of my Children to sell all or any part of my Lands & purchase other Lands with the monies whare or in what Country they may think best for the use above mentioned-- I do Nominate & appoint my beloved Son Peter Macdonald and my friend Archelaus Watkins to be my Lawfull Executors - this the twenty seventh day of December the year of our Lord & Saviour Jesus Christ 1816 and in the forty first year of the Soveranety & Independency of the Unighted States of America-----
