not be ~~by any~~ very remote, Do make and ordain this my last Will
& Testament in manner and form following Viz.-----
First My Boul I Commend to God- My body I desire decently interred
at the discretion of my Exr^l herein after named.- All my property
both real and personal, the reward of a long life of industry
I give and devise in manner following Viz First I direct my
funeral charges and expences to be paid, having no ohter debts
the payment of which to order in this my last will and Testament
Item I give and bequeath to my beloved wife Margaret Pullig:
one third part of all my real or landed estate to be held by her
during her natural life- at the decease of my said wife all the
land herein given to her, or to which she is entitled by virtue
of this instrument I give and devise to my three Daughters Viz
Elizabeth Gear Rebecca Scott and Nancy Robertson to be entitled
to equal shares respectively.-----
Item I give likewise to my beloved wife a negro boy named Dick
for her use and benefit durin^g her lifetime- at the decease
of my wife I give and bequeath the said negro Dick to my Grand
son Anthony Owens-----
I give to my beloved wife the following property. Viz one Horse
Two Cows and Calves, all the ready money or Cash in my possession
at the time of my death as much Household & Kitchen furniture
as will be necessary for her use, the Selection of which, is left
to ~~the~~ judgement and ~~discretion~~ of my Ex^{rs} should ~~the~~ prov-
ision herein made ~~be~~ for the maintenance of my wife Margaret
be inadequate, I enjoin it upon my son Phillip as a filial duty
and direct him to contribute from his dividend of my estate
such pecuniary or other relief as may be necessary to her decent
and comfortable support - should my wife experience any difficult

in the management of the negro girl Mason, above given to her & in which property she has a limited estate it is my will and pleasure that my said wife dispose of said negro in such manner as she may deem most conducive to her, interest, Item- I give and devise to my Son Phillip Pullig Two Hundred acres of land commonly called Murphs' Tract adjoining lands of Jno Chappell and lands herein given and devised by the Testator to be held and possess'd by said Phillip in fee simple-----

I give and bequeath to my son Phillip one negro man named Abraham I give to my son Phillip, My Silver Watch, to be kept as a family relic ~~taxmywife~~

All my landed, property (except that herein before given, and devised to my wife and my son Phillip,) I give and devise to my Children and grand Children herein after named, to each in the manner and proportion following,-----

I give and devise to my Grand Children Anthony ~~anmks~~ Owens Henry Owens and Margaret Owens jointly one fifth of the lands above mentioned in fee simple- subject however to the payment of a claim of Two hundred Dollars as herein after directed,---

I give and bequeath to Elizabeth Gear (formely Owens) Two hundred Dollars, to be drawn from the real property above given and devised to her Children , Anthony Owens, Henry Owens and Margaret Owens- the said legacy or gift is in consideration of any legal or equitable claim, which said Elizabeth may have upon any part of my real estate-----

I give and devise to my daughter Rebecca Scott likewise one fifth of my real estate, above mentioned to her and her heirs forever, I give and bequeath to my Daughter Anna Cook one fifth of my real estate before mentioned, to be held by her during her lifetime, at the death of said Anna, I desire the property herein given to her to decend to her Children in fee simple-----

I give to my Daughter Anna a negro girl named Christena
But should said Anna die, leaving no lawful child or children
living at the time of her death - Then and in that case I
her direct and order all the property herein given to her either
real or personal, to be divided equally among my children-
or such persons as may be nearest to said Anna by the ties of
Consanguinity or blood, -----

I give and devise to my Daughter Nancy E Robertson one Fifth
of my real estate before mentioned to her and her heirs forever.

I give and bequeath to my Daughter Nancy a negro girl named
Elizabeth or Bets-----

I give and bequeath to my Daughter Maria Pare the remaining
one Fifth of my landed property before mentioned, to be hold
by her during the term of her natural life-- at the death of
said Maria, I will and order said property to descend to the
lawful issue of said Maria in fee simple-----

Item I give to my Daughter Maria a negro boy named Donnar

But should said Maria die leaving no lawful Child or Children
living at the time of her death--- Then and in that Case, I desire
all the property both real and personal herein given to her,
to be divided equally among my four ~~Wg~~ Children Viz- Phillip

Pullig Elizabeth Gear, Rebecca Scott & Nancy Robertson, or
among such persons, as may be nearest to said Maria by the
ties of consanguinity" Item I give and bequeath to my Grand
daughter Harriet Turnipseed as follows Viz one negro girl named
Dannis also one Hundred Dollars in Cash-- Item I give and

bequeath to my son in law Jacob Turnipseed Five Dollars in Cash-
I give to my grand son Tho^s Pullig my Shot Gun, and whatever
appurtains thereto-----

I direct & order the following negroes sold Viz Ben, Sam, &
Alfred and the money accruing accruing therefrom equally
divided among all my Children Viz Phillip, Elizabeth Anna,
Maria, Rebecca, and Nancy-----

I give to my son Jno Pullig one Hundred and fifty Dollars

Lastly I do hereby nominate and appoint my son Phillip Pullig and my Friend Christian Bookter Ex^{rs} of this my last will and Testament - hereby revoking and makeing void all former wills and legacies by me heretofore made-----
