I give to my Son John McLean, my negro boy Wyatt, now in the possession of Charles Beek of Columbia.-----

I give to my Son William McLean , my negro boy Joseph, now ~~in~~ about eight years old.-----

I give to my infant Son Andrew Toland my negro boy Simean about five years old, I give to my daughter Jane my girl Flora now in the employment of Mrs Cooper.-----

I give to my daughter Eliza my girl Jane daughter of Jemima

I give to my daughter Mary my yellow girl Harriet,-----

I give to my daughter Caladonia my girl Dolly, as my Son Archibald Hugh has been provided for to the extent of the value of a negro boy by the will of my father , I ~~give~~ have not given him any special legacy.-----

I give and devise to my son Donald all my right & interest in the ^{line} stage ~~line~~ from Camden to Fayetteville, being one fourth of the capital stock in said line, together with all the

dividends which may be due on said stock, to be used as a fund to enable said Donald to graduate in the South Carolina College, And I do by these presents constitute my friend E. L. Ellsworth sole trustee to manage & control said fund for the purpose aforesaid , I give & devise to my affectionate wife

Eliza the following Slaves, to wit, Jemima Pompey, Susan , Bacchus & Big Mary, I give & devise also to my wife the

balance of the Bond due me by M & D McLean amounting to between three & four thousand dollars, to be used by her during her

my children .-----

I give & devise all my right title & interest in the estate to my father, both real & personal, to my four daughters to be used exclusively as a fund for their education, And I do hereby nominate constitute & appoint my three sisters Trustees to have & to hold the estate as aforesaid for the uses & purposes as aforesaid, The above devise or legacy to my four daughters, it is to be understood has reference alone to the proceeds or profits arising from the estate, of my father ; as my father has by his will provided for the ultimate distribution of his estate, All the rest & residue of my estate both real & personal .-----

I give to my wife affectionate wife . And I do by these presents nominate constitute & appoint my particular friends H. A. Peay Will Myers Daniel McLean & John C. McLaurin Sole executors of this my last will & testament of this In witness testimony whereof I have hereunto set my hand & seal this the 11th day of August in the year of our Lord one thousand and eight hundred & fifty one .-----
