Faust for and during the term of his natural life and after his death to belong to the lawful heirs of his body and Should my Said Son die leaving no lawful issue then and in such case it is my will that all the property contained in this Item shall revert and belong to my Said Daughter Mary C Pierce and Son Clement C. Faust and their respecting children

Item 5 Should my said Daughter Mary C Pierce or Son Clement die leaving no lawful Issue then and in such case the property willed or intended for either of them shall belong to the Survivor of them

my Estate I give my Executor hereinafter named full power to Sell and dispose of the same upon such terms and credit as he shall deem proper and then divide the proceeds of the
