Bond note or any other title my Debts and funeral Expenses
excepted which my aforesaid friend John Hiron is hereby
to pay .

5 thly I give and bequeath unto my friend Naomi Pierce
1 bay Horse. and lastly I do hereby nominate and appoint
my true and trusty friend John Hiron & Joel Adams the whole
and sole Executors of this my last Will and Testament
Ratifying and confirming this and no other to be my last
Will and Testament In witness whereof I have hereunto
set my hand and seal this TwenteFifth Day of January One
Thousand Seven hundred and Ninety two
