IN THE NAME OF GOD AMEN. I Elizabeth Harris the lawful wife of Edward Harris of the Town of Columbia in the District and State aforesaid, being sick & infirm in body but of sound and disposing mind and memory and contemplating the uncertainties of death, or when it may please almighty God to call hence me hence, do make and ordain this to be my last will and Testament.

After my death it is my will and desire that my husband Edward Harris during his natural life should use, possess and enjoy all of my estate both real and personal to which I am now or may hereafter become entitled either in Trust or otherwise and for which said purpose I do hereby loan to the said Edward Harris during his natural life all that Lot or parcel of ground situate in the Town of Columbia on Gervais Street, containing one half acre and known in the plan of the Town by number Seventy five (75) together with the dwelling house thereon, and the household and Kitchen furniture, I do hereby further loan to my said husband Edward Harris during his natural life the following negro slaves Tosit Jenny and her Children Salvy and Mary and Bill and a negro Boy Bob and their future increase during the said period, but under the express conditions and restrictions that they shall not be removed by him from the Town of Columbia and should he remove the same or any part of said personal estate, then the loan hereby made to cease and become null and void. It is my further will and desire and I do hereby give devise and bequeath after the death of my said husband Edward Harris the whole of my estate both real and personal in manner following - myn house and Lot herein before mentioned I give and devise to my Neice Emiline Edmund Casey to her and her heirs forever and if she dies without issue then to my other legal heirs and representatives. The negroes also herein before mentioned I give and bequeath with their future issue and increase to my nearest & relations by Blood and to be disposed of in no other manner then such as will retain

then among said relations and which said division and distribution I leave to . to discretion and judgement of my executors herein after named. I further give and bequeath to my neice Emilie Edmund Casey and my sister Rosanna Hogan the whole of my wearing apparel together with Two Bed Quilts and a set of Bed Balants to be equally divided between them by my Executors immediately after my death--- and lastly I do hereby constitute and appoint Adam Edgar Squire Lonam and Lemuel Carey Executors to this my last will and Testament .
