I Francis William Donlevy of the Town of Columbia South Carolina being of sound mind, do make this my last will & testament, hereby revoking all other wills heretofore made by me-----

I bequeath my Soul to God, trusting in his infinite mercy, that as he called it into this world from a State of none existence he will think it worth Saving-----

I give & bequeath unto Manuel Antonio David Ewart & Henry OLoane Esq all my real & personal property, to be by them disposed of as I shall hereafter direct -

The above named persons or either of them are hereby authorised to receive from the ferme of Mrs Wm Donlevy & Co the sum of Three hundred Dollars (Say \$300) being my half of the profit rent of the House & Lot in which our business is carried on)

the said \$300 to be laid out on a good bill of exchange (on Liverpool or Belfast and remitted to Doctor Patrick Donlevy

Ballymote Co, Sligo Ireland (and the duplicate thereof to Phillip Gomley Esq of said place). (A similar remittance

I authorise and request may be made to the said P Donlevy be annually for four years from the first Day of duly last)

about the same period of the year Say Nov or Dec as may prove most convenient a letter from Patrick Donlevy, Catharine

Donlevy Senr or Junior (the writing to correspond with some of each which is in the hands of H OLoane Esq) acknowledging the receipt of the said bills shall be a good & sufficient voucher-----

Having formed a copartnership on the 18th Ult. with Cunningham Boyle & H OLoane under the usual firm of F. M. Donlevy & Co I have put into said firm as my Capital the sum of Two Thousand four hundred & forty six ¹² ~~100~~ Dollars, together with my half of a considerable amount of debts which we considered a little doubtful, the said sums together with my one fourth of the

profits (if any) to be retained in the firm x\$500 P an: excepted see article of copartnership) until the expiration of the same when if the parties discontinue the copartnership the said Manuel Antonio David Ewart & Henry OLoane shall collect my share of the same & remit it as usual to my Father F Donlevy to Ireland -----

That at any time the partners decline carrying on business it shall & may be lawful for C Boyle his heirs etc with the consent of the said David Ewart H OLoane and Manuel Antonio to either rent or sell the said House & Lott as to them shall seem most for the interest of the parties concerned, I would prefer renting the place at Six hundred dollars P an: to a good tenant who would ensure the premises against fire, unless there could be Eight Thousand dollars (at least obtained for it)-----

Should the premises be sold it is my wish that my half of the proceeds be invested in Unites States Stock on the best terms and I request of the M Antonio D Ewart & H OLoane to do so, and receive the Interest on the same, and remit it annually to the Patrick Donlevy his heirs to Ireland.

I hereby constitute & appoint the said Manuel Antonio David Ewart & Henry OLoane, the executors of this my last will & testament , the act of any two of whom shall be binding on the third. provided the House & lott shall be sold and the half proceeds invested in Goverment Stock as directed, itmis my wish that said stock be deposited in the United States branch bank in Charleston, until such time as my Ex^rs receive a letter from Ireland ordering it to be remitted there, the said letter is to be signed Dan¹. OConnor for in his absence Charles OConnor and Phillip Gomley. and their hand writing to be certified by the provost of Sligo who will affix the corporation Seal to it-----
