I George Romanstine of the State & District aforesaid being in a low state of Health but of sound mind & memory do make and declare this to be my Last Will & Testament

First. I desire that all my just debts be paid.

Secondly - I lend to my beloved wife Margaret Romanstine the House & plantation on which I now live, also my negro woman, named Doli & one feather bed during her natural life.

Thirdly - I give to my beloved son John Romanstine one third part of all my personal estate, & at the death of his mother I also give him one third of my Lands & one third of the personal estate loaned to her.

Fourthly, I give to my beloved Daughter Leonora Cofield one third part of all my personal estate, and at the death of her mother I also give her one third part of the lands & personal estate loaned her -

Fifthly I lend to my beloved Daughter Catherine Bouknight during her natural life one third part of all my personal estate, & at the death of her mother I also lend her one third part of the lands & personal estate loaned her and at the death of my said Daughter I give & bequeath all the property herein loaned to her to the Heirs of her body. Shou'd she leave any, but shou'd she die leaving no Heirs of her body, then & in that case I give and bequeath the property loaned to my said Daughter Catherine to my son John & my Daughter Leonora to be divided between them share & share alike -

Sixthly It is my Will and desire that my Executors as soon after my decease as convenient cause a Sale to be made on a credit of six or Twelve months of all my personal property, except my negroes, & that the proceeds thereof be equal-
