I, Harriet Howell of the District and State aforesaid do make and ordain this my last will and testament.

First. I nominate constitute and appoint Dr. John Fisher to be the Executor of this my last will and testament.

Second. I will and bequeath to my brother William Howell the sum of Eleven hundred and fifty Seven Dollars and Ninety cents, out of the proceeds of a certain Bond for Six thousand two hundred and Ninety Eight Dollars, and Eighty Eight cents, given to me by my mother Mrs. Martha Howell on the Eighteenth day of June A.D. 1850; the said sum of Eleven hundred and fifty seven Dollars and Ninety cents to be paid to my said Brother William Howell in Cash out of the proceeds of said Bond, by my said Executor. My object in making this bequest to my brother William is to give him as much out of my own Estate, as Each of my three Sisters, Mrs. Epps G. Trezvant, Jesse M. Howell and Grace Howell will receive under the provisions of my fathers will from that portion of his Estate which was set off and assigned to me by the Court of Equity for Richland District at June Term 1849.

Third. The balance of the said Bond for six thousand two hundred and ninety Eight Dollars and Eighty Eight cents, I will and bequeath unto my beloved Mother Mrs Martha Howell for and during the term of her natural life; that is to say I desire that the balance of the said Bond be held by my said Executor and that no part of the principal or interest of said balance be collected from my said mother during her natural life, and after her death, I will and bequeath the said balance (without interest up to the time of my mother's death) or such equivalent for said balance as may hereafter be agreed upon between my said mother and my brother Jesse Malachi Howell, unto my said brother Jesse Malachi Howell, his heirs and as-

signs forever.
