of the District of Richland State aforesaid being weak in body but of sound and disposing mind memory and understanding Do make and ordain this my last will and Testament in manner and form following that is to say, 1st. It is my will and desire that as soon after my decease as may be practicable, my Executors hereinafter named should sell and dispose of the best advantage my Negro man named Frank my two wagons, one a four horse and the other a two horse Team. the harness belonging to the same my three mules and a Tract of Woodland containing about hundred and thirty Seven acres more or less situated about ten or Eleven miles from Columbia adjoining Land of Foster Robert and John Davis and Willy Jones and that they my said Executors should apply the proceeds of the Sale of the above mentioned real and personal Estate as far as may be necessary to the payment of all my debts And after the payment of my said debts to invest whatever balance may remain of the proceeds of said Sale in some profitable stock or other security and to pay ^{over} ~~on~~ the interest which may from time to time accrue thereon to my wife Agness Green for the Support of her self and my Children- Item- It is further my will and desire that the house and Lot in which I reside and the house and Lot in the rear of the Same should be kept by my Executors for the use of my wife and Children. that they should be permitted to continue to occupy the one and to receive the rent of the other and that this arrangement should exist as long as my said wife may remain unmarried. But should she again marry it is then my will and desire that my said Executors should as soon after such Event as they advantageously can sell and dispose of my said two houses and Lot- Should pay over to my said wife her third part of the proceeds of said Sale and should invest the remainder ~~in~~ of said proceeds in some profitable security and apply the Interest thereof to the Exclusive use

and benefit of my said children until in the discretion of my said Executors and according to their best judgment my said children shall arrive at such maturity as might make it proper and expedient to pay over to them their respective shares of the principal of said investment and then ~~it~~ to pay over to them as they may severally be qualified to receive of their respective shares of said principal for their exclusive use benefit and behoof forever to apply or dispose of as they may think proper-

Lastly - I do hereby nominate constitute and appoint Dr William Reynolds and D John Fisher Executors of this my last will and Testament hereby revoking any will or wills heretofore by me made and declaring this to be ~~my~~ last will and Testament.
