IN THE NAME OF GOD AMEN- Know all men by these presents that I Ison Woodard of Richland District in the State of South Carolina Being of Sound mind and disposing memory, and Considering the uncertainty of human life- Do make and ordain this my last Will and Testament in manner and form following- that is to Say- In the first place I give and Bequeath to my wife Nancy Woodard, the possession and use of the following property Real and Personal, during her natural life Viz. the Mansion house where I now live and fifty acres of land with all the furniture belonging to the House- also Five Negroes, Named as follows, Mariah, Judy, Ann Charles, and Viallett- All the above property at the Death of my wife Nancy Woodard is to go to my Son Lieuellan Woodard, and his Children or to the Children of Elizabeth McKenzie.-

In the Second place I give and Bequeath to my grand Son John Woodard House Two Hundred and fifty acres of Land called the Gibson land and the Killingsworth land, and One Hundred acres of Swamp land on the Congaree River which I Bought from, Barsh- also Five Hundred Acres of Swamp land lying on the North East Side of Cedar Creek, adjoining Huger's old Ferry- known commonly as Lightwoods old field- also Twelve Negroes Named as follows Charlotte Amanda William Henryetta Eliza Frank Middleton Sarah, and her Two children Peet and Charles and Abrahm and Yellow Sam a boy - also one Waggon and two Mules- one Riding Horse- Two Beds Bedsteads, and furniture, and one Hundred dollars to be laid out in house furniture- If the said John Woodard House Should die, leaving no children, then the above property Real and Personal, given to him, I wish to go to my Son Lieuellan Woodard, and his Children, or to the Children of Elizabeth McKenzie In the third place I give and Bequeath to my Three grand Sons, Ison House Thomas House, and Samuel House Eighteen Hundred dollars To be equally divided between them, paying to each his Share at Twenty one years of age without Interest- I give and Bequeath the Tract of land which I purchased of Samuel Addison,

to the Said Woodard House- and fifty acres of land to be taken out of the land, which I purchased of William Shiver I give and Bequeath the mansion House and tract of land, where on John House now resides containing one Hundred and Thirty Acres, to Thomas House and Samuel House, my afore mentioned grand Sons;

I give and Bequeath to my grand Daughter Sarah House the sum of two Hundred dollars- I give and Bequeath to my grand Sons, Jesse House and Reuben House, and to my grand Daughter, Elizabeth Leddington, Five Dollars each- In the last place- I give and Bequeath to my Son Lieuellan Woodard, all the Balance or Residue of my Estate Both Real and Personal and every Species of Property of which I may be possessed or be the owner at my death to him the Said Lieuellan Woodard, and his children, or to the children of Elizabeth McKenzie-

I hereby constitute and ordain my Son Lieuellan Woodard Ts. Seny John Williams and James McKenzie to be the Executors of my foregoing last will and Testament- In witness where of I have here unto Sett my hand and Seal This the 12 day of May in the year of our Lord Eighteen Hundred and Thirty Nine-
