Adelade-----Item I give and bequeath unto my Executors

above named, (intrust) for my Son Uriah Deleon, my Negroe

Man named Ben together with a Negroe man named David that

their wages may assist in Supporting him with Cloathes and

Board and it my Will and desire, that if the Said Negroes

does not behave themselves, I do hereby give my said Exec-

utors full Power to dispose of them to the best Advantage,

and the amount to be appropriated to the best advantage, the

income of which to support my said Son Uriah at his demise

the same shall be divided among my daughters share and share

alike;

Item--I give and bequeath unto my Wife Hannah Deleon, and

four Daughters, Louisa, Henrretta, Rebecca, and Adelade

or the Survivors of them all my Horses, Cattle, Carriages

and every thing appertaining to them, the same to be either

Sold as they may deem most fit to be Valued and divided share

and share alike ---
