It is my desire that all my just debts if any should be
first paid out of my whole Estate nd 2. I bequeath unto my
beloved Daughter Rebecca Maria Diseker and give to her the
following Negro Slaves to witt. Perry Anne November and
Caeser, rd 3. I give and bequeath unto my beloved Daughter
Grace Howell Diseker the following negroes to witt Damond
Lavinia Luezer Ben, and Emaline 4th I give unto my Son Joel
Diseker the following Negroes Viz. John Easter Chana Dave
Nice and Maria 5th I give and bequeath unto my Grand Son
John Diseker Son of my Son William Diseker Negro boy Jordan
It is my wish that if my Grand Son John Should die without
any bodily Heir or before he arrives at the age of Twenty
one that the above named Negro Jordan shall go to his Sis-
ter Grace and if both should happen to die without lawful
issue then the said Negro shall be the property of of my
Daughter Grace Howell Diseker also to my daughter Grace
Howell Diseker I give Negro woman named Nelly and to my
Daughter Rebecca Maria Diseker Negro man Joe, to my Son Joel
I give Said Negroes Viz. Sylvia and Jim. I also give Negro
Woman Minney to my Daughter Grace Howell Diseker, and Negroe
Woman Dilce to my Daughter Rebecca Maria Diseker also my
negro woman old Sylva to Rebecca. It is my will that my
real Estate shall be divided equally among my Three children
Joel- Rebecca and Grace Viz that Joels proportion shall be
laid off on the N. East part of my possessions adjoining
Lands of Martin Marshall Will Myers and John A. Reese the
other parts to be laid out equally to my two daughters above
named as follows for a line to be cut through and my Daughter

Rebecca to have the upper part adjoining lands of Vinson and Jesse W. Goodwyns and for my Daughter Grace to have the lower part adjoining Lands of John Hopkins. My Tract of Land in the Sand Hills which I purchased of Daniel Gurr I wish equally divided between my Three children Joel, Rebecca and Grace I give to my Son Joel Diseker the follow Hoses and mules Viz Mule Pompey Mule Yellow Jack and Stud Colt to my Daughter Rebecca I give my Bay Mare and Sorrell Mule called Starling to my Daughter Grace I give Sorrell Mare and Mule called Black Jack, My Stock of Cattle and Hogs I wish equally divided between my three Children Joel, Rebecca and Grace my plantation I wish kept up and carried on as though I was alive My Estate not to be divided until or otherwise the Legatees not to receive these Legacies until they become of age. It is also my desire that if either of my three named Children Joel Rebecca or Grace Should happen to die without lawful Issue before they become of age that this or her part Shall become the property of the Survivor or Survivors of Said deceased my Household and Kitchen furniture I wish to be divided among (Equally) my three children, Joel Rebecca and Grace-- and all the property I have given to my named children I give to them with the increase thereof. and their Heirs forever- Lastly I do hereby and appoint my beloved friends William Myers Sen. and James Rowan Executors to this my last Will.
