I Jacob Faust of the ~~State~~ aforesaid, Planter,
being very Sick and weak in Boddy, but of perfect mind
and Memory, Thanks be given unto God, calling unto mind the
Mortality of my Body, and Knowing that it is appointed for
all men once to Die, Do make and ordain this my last Will
and Testament; that is to Say, Principally and first of all,
I give and Recommend my Soul into the hand of Almighty God
that gave it, and my Body I Recommend to the Earth, to be
buried in a Decent Christian Burial at the Descretion of
my friends, nothing Doubting but at the general Resurrection
I shall Receive the Same again, by the mighty power of God,
and as Touching Such worldly Estate wherewith it has pleased
God to Bless me in this life, I give Devise and Dispose of
the Same in the following form and Manner:

First I give and Bequeath to my Son Dehiel Faust, a plan-
tation and tract of land Containing one hundred acres ,
where on I now live, on his paying to his Brothers and
Sisters (Heirs to the Estate of Henry Galmon) Legacies
Due to them by the last will and Testament of the Said
Henry Galmon.

Secondly I Desire that all the Rest of my personal Estate
be Disposed of at publick sail and after my just Debts
being paid, the money arising from the sail to be Equally
Divided Between my Children and my Grand Daughter Keziah
Lery, to have an Equal part with them.

I likewise make ordain Constitute and Appoint, Jasper Faust
and Daniel Faust(my Sons) Executors of this my last will
and Testament, and I do hereby Utterly Disalow, Revoke and
annul all and every other former Testaments , Wills

Legacies, Bequests and Executors by me, in any way
Before named Willed and bequeathed, Ratifying and
Confirming this, and no other, to be my last will and
Testament In ~~WITNESS~~ whereof I have hereunto Set my hand
and Seal this Seventeenth Day of September in the year of
our Lord one thousand seven hundred and ninety three, and
in the Eighteenth year of American Indpendance.

of each other, have here unto Subscribed our Names.
