

South Carolina - In the name of God Amen.

I Jasper Faust of Richland District; being old and infirm but of sound and disposing mind do make and ordain this my last will and Testament in manner and form following, Viz.

first - I hereby direct, and desire my Exr' hereinafter named to sell at public or private sale the following negroes, Hercules, Sam, and Peter, and to appropriate the money arising from their sale, to the payment of my just debts, if so much be necessary.

Item 2nd. If any money should remain from the sale of the above negroes, after the payment of my just debts, I desire my Ex'r to pay over the same to my beloved wife Esther to be disposed of by her as she may think proper.

Item 3rd. I give and bequeath to my beloved wife Esther, the tract of land on which I live, containing one hundred and eight acres, for her use and benefit during the term of her natural life, and at her decease or termination of her life estate, to descend to my Nephew Christian Bookter, to be held and possessed by him and his heirs forever.

Item 4th. I give and bequeath to my beloved wife Esther, the following negroes, Viz - ~~John~~, John and Thomas, for her use and benefit during the term of her natural life, and at her decease, said negroes to be held and possessed by my nephew Christian Bookter or his heirs forever.

Item 5th. I give and bequeath to my beloved wife all my stock of cattle, horses, hogs, all my plantation tools and implements; all my house hold and kitchen furniture to be used and disposed of as she may think proper.

Lastly. I hereby nominate and appoint my friend Christian Bookter Executor to this my last will and Testament hereby revoking and annulling all other wills by me at any time heretofore made declaring this and no other to be my last.
