

In the name of God amen I Jesse Baker of Richland District and State of South Carolina being weak in body but of sound and disposing mind and understanding, considering the certainty of death and the uncertainty of the time thereof, and being desirous to settle my wordly affairs, and thereby be the better prepared to leave this world when it shall please God to call be hence, do therefore make and publish this my last Will and Testament in manner and form following that is to say- Item- I give and devise unto my beloved wife Grace Baker and her heirs forever one Tract of Land lying on Mill Creek in Richland District, bounding on Malachi Howells mill Tract containing one hundred Acres; Also I give and devise unto her and her heirs forever one Tract of Land containing one hundred and Sixty four acres, lying on the S. East fork of Mill Creek bounding on the S. East by Col. Rob.t Lyles Land- Also I lend unto my Wife Grace Bader during her natural life, the whole of my Bluff Plantation or Tract of Land containin Three hundred and twenty three Acres, bounding at present by Land belonging to James Hopkins the Estate of Tho. J. Howell and Jesse P. Taylor-- Also I give and bequeath unto my beloved wife Grace Baker the whole of my personal Estate, Consisting of the whole of my Negros together with their Issue, Stock of Horses, Cattle and hogs, Household and Kitchen furniture Plantation Tools of every description, together with the whole of my Books, to her, and to her heirs forever-- Item --I give and devise unto my Niece Esther Nevill, to her and to the heirs of her body forever, one tract of Land containing Four hundred and fifty four Acres lying on Terrible Creek Waters of Spears Creek, and Waters of the Wateree River lying on or near the line dividing Richland and Kershaw Districts--Also after the death of my beloved wife Grace Baker I give and devise unto my Niece Esther

Nevill to her, and to the heirs of her body forever, the whole of my Bluff Plantation or Tract of Land containing Three hundred and twenty three Acres.

Item--Also a Tract of Land lying in Richland District on Cedar Creek Waters of the Congaree River, lately conveyed by me to Sarah E Key--I do in this my last will and Testament give and devise the same unto her and her heirs forever---Lastly, I do hereby nominate Canstitute and appoint my dear Wife Grace Baker Executrix, and my friends Malachi Howell, Joseph B. Stanton and Thomas Heath Executors to this my last will and Testament, revoking and annulling all former Wills by me made ratifying and confirming this and none other to be my last will and Testament.
