IN THE NAME OF GOD? AMEN I Jesse Chandler Sonr.- of Richland  
District and State of South Carolina being sound in mind and  
in perfect health, but aware of the uncertainty of human exis-  
tance and being desirous of disposing of such worldly goods as  
it hath pleased God to bestow upon me, do, make and ordain this  
my last Will and Testament. That is to say- Imprimis I desire  
that my Wife Mary Ann Chandler have the full and perfect use of  
the whole of my Estate both real and personal, (after my just  
debts and funeral expences are paid) for and during her natural  
life. Item, I desire my Executors herein after named, to raise,  
as soon as they conveniently can, after the death of my Wife,  
eight hundred dollars, and cause the Said sum to be paid, to  
the surviving heirs of my deceased daughter Mary House, each a  
proportionable share Item. I give and bequeath unto my Son Jesse  
Chandler and my Daughter Elizabeth Collins Wife of Smart Collins  
and the heirs of their respective bodies, one tract of Land  
where on I now live, and four negroes, to wit. One woman named  
Martia, two men named Juba the other Abraham and one boy named  
Carolina the whole to be equally divided between my two said  
Children after the death of my wife ----- Item I give to my  
Daughter Rebecca Chandler and the heirs of her body, two negroes  
To wit---Satyra a wench and her Daughter Lucy with their in-  
crease-----Item I give to my Daughter Martha Chandler and the  
heirs of her body, a negroe woman named Mary and her child Lizzy  
with their increase--- Item. I give to my Daughter Mary Hannah  
Chandle and the heirs of her body, a negroe girl named Rachael  
and a boy named Isnao,----- If any of my above named children  
should die without issue I desire that their share should be  
equally divided among the survivors. I give to my son Jesse  
My Daughters Rebecca, Martha and Mary Hannah, each one feather

tween my Son Jesse Chandle and my dau hter Elizabeth Collins,

Lastly- I nominate, constitute and appoint my wife Mary Ann  
Chandle Executorix and my Son-in-law Smart Collins and my  
Son Jesse Chandler Executors of this my last Will and Testament-  
In testamony whereof I have hereunto set my hand and affixed  
my seal this twenty third day of September in the year of our  
Lord one thousand eight hundred and twenty

nounced by the said Jesse Chandler                      his
