I John Parr of the Town of Columbia in the State aforesaid being weak in body but of sound mind and memory thanks be to God for the same, do make and ordain this to be my last will and Testament in manner and form following .-----

First I give devise and bequeath unto my wife Mary the whole of my Estate both real and personal for and during the term of her natural life,-----

Item 2nd- After the death of my said wife, I give devise and bequeath the one Moity or half of said Estate both real and personal unto my Daughter Caroline Harriet Branthwait the wife of Edward Branthwait to and for her sole and separate use benefit and behoof not withstanding her coverture and not to be in any manner subject or liable to the debts or Contracts of her present or future husband, and after her death the same to belong to the heirs of her body .-----

Item 3d- I give^{devise} and bequeath the remaining moity or half of my said real and personal Estate unto my Son James Davis Parr (after the death of his Mother) to him and his Heirs for ever,-----

Item -4 Should either of my said Children die leaving no lawful heirs it is my will that his or her respective portion of my said Estate shall revert and belong to the Survivor of them his or her heirs for ever subject however to the same uses, limitations, and restrictions as is expressed and contained in Item Second should it so happen that my Daughter should be the Survivor as I do not intend that any part of my Estate should be in any manner liable for the debts or Contracts of my Daughters husband either present or future,-----

Lastly I do hereby nominate and appoint my said wife Mary Executrix and my Friends Daniel Faust and Sidney Crane Executors of this my last will and Testament hereby revoking and making void all wills by me at any time heretofore made declaring this and no other to be my last .-----
