To be divided from Time to Time as the Children arrive at age,
Viz) The Boys at Twenty one years, The Girls Eighteen Years old,
Thirdly- I give and Bequeath to my Son Mr Benjamin Frost and his
Wife, all the Stock of Cattle and their Issue Theretofore
lent to him, and in his possession, And should he marry, and
his Wife or Wives) have Children by him, Then shall they be
devided Share and Share alike, as they arrive at the aforesaid
Years, (Viz) The Boys at Twenty One and the Girls at Eighteen
Years,---- Fourthly- I give and Bequeath to my Daughter Ann
McCullough, and to the Heirs of Her Body all my Remaining Stock
of Cattle, Hogs, Horses, Etc Together with all my Household
furniture of Every discription whatsoever; In the following
manner (Viz) my Daughter Ann shall have the Free use of the
Horned Cattle such as to Milk, or, for the use of her Family
may kill a Bul Occasionally, The He Cattle and Old Cows shall
from Time to Time be Sold, and the Money, or Monies thereby
arising shall be Converted Towards the Schooling and Supporting
the Said Children, the Overplus of the money or monies there
arising shall from Time to Time be put to Interest, In order
to purchase a peice of Land, or the money to be Equally divided
amongst the Said Children, and the Mother, when her Youngest
Child arrives at age,----- Lastly I hereby appoint The
Said William Sowden Sole Executor of this my Last Will and
