touching my worldly Estate I dispose of the same in following
manner It is my will and desire that my Executors hereafter
named do sell to the best advantage Two acres of Land which
I own, situate in Columbia near the College the proceeds
whereof to be applied towards the payments of my Debts and
I do hereby vest them with full power to sell the same & to
make Titles therefor.

I give devise and bequeath all my Estate both real and per-
sonal unto my beloved wife Eliza D Howell and my to my
dear adopted Daughter Eliza Howell Goodwyn to them and their
Heirs absolutely and forever, to be divided equally between
them. But if my said adopted Daughter Eliza Howell Goodwyn
shall die without leaving any Issue alive at her death, then
it is my will and desire that her share of my Real Estate
shall descend to and vest in my Nephews & Neices the Children
of Lucy ~~Stanton~~ Stanton and Elizabeth Ware, to them and their
Heirs forever.

I give and bequeath unto each of the Children of my said Nieces
D
Lucy Stanton and Elizabeth Ware the sum of five hundred Dollars
to be paid them within Twelve months after they shall respec-
tively attain the age of Twenty one, or be married, which
ever of these events shall first happen; but if either or any
of the aforesaid Children shall die before attaining his or
her age of Twenty one, or before his or her marriage when his
or her Legacy as aforesaid shall be considered

as lapsed, & his or her Heirs shall not be entitled to
claim said Legacy.

I give and bequeath unto my said wife and my said adopted
daughter Eliza Howell Goodwyn a full and entire confirmation
of a Deed executed by me five or six years ago, by which I
conveyed to Thomas J. Howell in Trust for them under certain
conditions, certain Negroes therein named, hereby declaring
my will to be that they shall have the full benefit of said
Deed & the property there in conveyed to them and their Heirs
forever and I do hereby Nominate appoint and constitute my said
wife Elizabe D. Howell and my said adopted Daughter Eliza
Howell Goodwyn Executrixes, and my Friends Thomas Heath , John
Howell and John J. Chappell Executors of this my last will &
Testament . Herby revoking and declaring void all former wills
by me made, and declaring this & this only to be my last Will &
Testament.
