give demise and dispose of the Same as follows ---

After all my just debts are paid I lend unto my beloved
Mother Amelia Broadway my negro Man Burrell my Stock of
cattle and Hogs, my household and kitchen furniture of
every description my wearing apparel and every other de-
scription of property of which I die possessed during Her
natural life and on Her decease I give the Same to my
Niece Grace Howell Broadway the Infant Daughter of my Bro-
ther Jonathan James Broadway to be delivered to Her when-
ever She becomes of age or marries. But if She should die
before becoming of age or of being married Then and in that
case I give the Same to my Brother Jonathan James Broadway,
and
my Sister Rebecca Broadway, to be equally divided between
them at the discretion of my Executors and to be possessed
and enjoyed by them and their Heirs forever. And I do here-
by Nominate and appoint my Brother Jonathan James Broadway,
and my Friend John Vinson Executors of this my last will
and Testament - and do hereby Revoke and Annul all former
wills or Testaments by me heretofore made and ratify and
confirm this to be my last will and Testament. In witness
