I Mary Clifton of the Town of Columbia in the State aforesaid, being of sound and disposing mind and memory, but in a low state of health; and mindful of the uncertainty of human life, do make, publish and declare this to be my last will and testament; hereby revoking and cancelling all former wills and testaments by me heretofore made.

Imprimis. I humbly commend my soul to Almighty God, hoping for mercy through the Atonement made by our blessed Saviour for the sins of mankind.

Item: It is my will and desire that all my personal estate wherever situated, except as hereinafter mentioned, be sold by my Executors (who shall qualify) to the best advantage, and that the proceeds of such sale shall be invested by them in stock, or loaned out upon good security; and I bequeath the annual interest thereof to my two sons William Claiborne Clifton, and Algernon Sydney Clifton during their lives, for the support of themselves and their children, and to be equally divided between my said sons; and upon the death of either of my said sons I bequeath one half of the said Stock, or money and securities and one half of the interest then due thereon to the children of my son who shall so die - and the descendants of any child who shall have died, such descendants taking among them their parents share: But if either of my said sons shall die without leaving issue alive at the time of his death, I bequeath his half of the said stock, money and securities to my surviving son for life, and upon his death to his children then living, and the issue of such as shall have died, they taking among them a parents share.

Item: I devise and bequeath my house and lot in Columbia

wherein I reside and my furniture to my Executors herein
after named in Trust for my son Algernon Sydney Clifton
and his children as a residence for them during his life;
And upon the death of my said son, I devise and bequeath
one half of the same to his children then living, and to
the descendants of such as shall have died, they taking a-
mong them their parents share; and the other half to Wil-
liam Claiborne Clifton for life, and after his death to
his children & descendants in like manner. my Executors
are hereby authorized and directed upon the death of my
said son to make titles in fee simple accordingly. And I
hereby authorize my said Executors or either of them, at
the request of my said son Algernon, to sell the property
mentioned in this clause of my will & to make titles in
fee to the purchaser, and to re-invest the proceeds of the
sale to the same uses. My apparel I bequeath to my son
Algernon. Lastly I nominate, constitute and appoint my son
William Claiborne Clifton and my friend Andrew Wallace to
be my Executors; hereby investing my Executor William C
Clifton with power separately to make sale of my personal
property in Alabama as directed by the first clause of this
will, and re-invest the proceeds; and my Executor Andrew
Wallace with like power as to my personal property in Car-
olina mentioned in said first clause.

Columbia this Eleventh day of April in the year of our Lord
one thousand eight hundred and thirty nine.
