

IN THE NAME OF GOD AMEN. I Mary Malone of Edgefield District being of Sound and disposing mind and memory thanks be to God for the same do make and Ordain this to be my last will and Testament in manner and form following.

Item 1 I give and bequeath unto my Son Eli Kennerly the following nine negro Slaves Viz. Davy, Stepney, Lucy, Maria, Dilcy, Julian, Joanna, Sherod and Betty together with their future Increase to him for and during the term of his natural life and after his death I then give and bequeath the said Slaves with their Increase unto the two Children of my said Son James Boatwright Kennerly and Julia Kennerly and also to such other child or children of my said Son here after to be born to them or to the Survivor of them share and share alike to be Equally divided between them - and should all the children of my said Son Eli Kennerly die during their minority, then and in such case, after the decease of my said Son it is my will that the said Slaves with their increase shall revert and belong to my grand children John W. Arthur and Eliza Arthur their heirs and assigns forever.

Item 2- I give devise and bequeath unto my grand Son John W. Arthur two Acres of Land in Columbia being the Eastward half of a Square between Washington and Plain, Barnwell and Henderson Streets- Also a negro Boy between fourteen and twenty five years of age to be purchased for him by my Son Eli Kennerly from the residue of my Estate- or if my Son prefers it he may give him my negro man Soloman in lieu of the negro so to be purchased, to him and his heirs forever.

Item 3 I give and bequeath to my Grand Son John W. Arthur a negro woman Grace and her two youngest Children Charlotte and Annaky with their future Increase in Trust for the use benefit and behoof of my Grand Daughter Julia Ancrum for and during the term of her natural life and after her death in trust for the use benefit and behoof of my Grand Daughter Eliza Arthur for during

the term of her life and after her death it is my will that said Slaves shall revert and become the property of my said Grand Son John W. Arthur his heirs and assigns forever.

Item 4 I give and bequeath to my said Grand Son John W. Arthur a negro Slave named Sylvia with her increase in trust for the life benefit and behoof of his Sister Eliza for and during the term of her natural life and then to the lawful heirs of her body and if no heirs then the said Slave with her increase to revert to himself and his Sister Julia Ancrum.

Item 5- I give ~~an~~ devise and bequeath unto my said Grand Son John W. Arthur the Western half of my Square of four Acres situate in Columbia between Taylor and Plain Barnwell and Henderson Street whereon Jesse Arthur now lives also four negroe Slaves Viz. Ned, Izrael, Delia and Moses with their future Increase upon the especial trust nevertheless that he shall permit and suffer his Father Jesse Arthur to use and possess the annual income arising from the rent hire or services of the said half Square of Land and four Slaves for and during the term of his natural life and it is my express will and intention that the said rent hire or perquisites arising from the said property shall in no wise be subject to any debts of the said Jesse Arthur and after his death I give the said two Acres of Land to my said Grand Son John W. Arthur his heirs and assigns forever and after the death of said Jesse Arthur I then give and bequeath the said four Slaves with their increase unto my three Grand Children John W. Arthur and Eliza Arthur and Julia Ancrum to them and to the Survivors of them their heirs forever. And should they all die without lawful issue then and in that case it is my will that the said four Slaves with their future increase as well as those Slaves devised in the fourth Item of this my will shall revert and belong to the Children then living of my Son Eli Kennerly his her or their heirs and assigns forever.

Item 6- I give devise and bequeath unto my Son Eli Kennerly the

rest and residue of my Estate both real and personal to him and his heirs and assigns for ever subject nevertheless to the payment of a Legacy to my Grand Son John W. Arthur as mentioned in the second item of this my will.

Lastly I do hereby nominate and appoint my Son Eli Kennerly and my friend James S. Guignard of Columbia Executors of this my last will and Testament hereby revoking and annulling all wills by me at any time heretofore made declaring this and no other to be my last will and Testament -- Witness my hand and Seal at Columbia this third day of October in the year of our Lord one thousand eight hundred and thirty-

I Mary Malone, do hereby make and constitute the following to
be a codicil to my last Will and Testament- Whereas the two
negro women Slaves Dilsey and Maria mentioned in my said last
Will I have lately sold to my Son Eli Kennerly - And have
bought from him two other negroes- a boy named Solly and a girl
named Sarah- Now therefore I do give and bequeath said two negroes
Solly and Sarah to my said Son Eli Kennerly during the term of
his natural life with the future increase of the said Sarah the
female and after his death I give and bequeath the said Slaves
to his children, the survivor or Survivors of them Share and
Share alike, to them and their heirs forever. and in the event
of all the children of my said son dying without leaving issue
then and in that case, I give and bequeath the said two negroes
Solly and Sarah with the increase as aforesaid, in like manner
to my other grand children, the children of my deceased daughter
Mrs Susannah Arthar to them the survivor or survivors of them,
Share and Share alike, and to their heirs and assigns forever.
