of sound and disposing mind, memory and understanding and calling
to remembrance the mortality of all flesh and that it is ap-
pointed for all men ~~once~~ to die do ~~make~~ and ordain this my last
will and testament in manner and form following (ie) I give and
bequeath my soul into the hands of Almighty God from whom I
received it, I desire my body to be buried in a decent and
christian like manner, nothing doubting but that at the general
resurrection, I shall again receive the same by the power of the
Almighty And touching such worldly estate as it has pleased the
Almighty to bless me with in this life, I give and dispose of the
same in Manner and form following. (to wit) Item. I give and beq-
ueath to Thomas Plummer and my son Robert Morrison a tract of
land containing Forty five Acres(more or less)situate and lying
in Rowan County in the State of North Carolina which was be-
queathed to me by my first husband Enoch Rice to them and their
Heirs forever subject however to the following restrictions Viz.
It is my desire that this tract of land shall be disposed of to
the best advantage and the proceeds arising from the sale of
said land shall be divided equally between the said Thomas Plummer
and my Son Robert Morrison and it is further my desire that the
share of the said Robert Morrison shall either remain in the
possession of the said Thomas Plummer or be by him invested in
some safe investment for the use and support of my aforesaid son
Robert Morrison. Item I give and bequeath to the aforesaid
Thomas Plummer and Robert Morrison all the right title and interest
or claim of dower which I have or may be entitled to in the
Estate of my second Husband John Morrison of Wake County North
Carolina in certain land and Negroes to be appropriated in the
same manner as the bequest made in the first section of this my

Last will and testament and it is my further desire that the said Thomas Plummer shall continue to exercise the necessary guardianship, and I do hereby, constitute and appoint him guardian over my aforesaid son Robert Morrison and further it is my will and desire what should happen aforesaid Thomas Plummer survived my said son Robert Morrison then and in that case it is my desire that the rest and residue of all such property money etc. as may remain in his hands unexpended belonging to or which has been appropriated towards the support of my said Son Robert Morrison shall become bona fide the property of the aforesaid Thomas Plummer his heirs and assigns forever and I do further constitute and appoint the aforesaid Thomas Plummer Executor to this my last will and testament revoking all other will or Wills made by me.
