

STATE OF SOUTH CAROLINA CHARLESTON DISTRICT, I Mary Susannah White of the City of Charlestan Spinster, being of sound mind and understanding Do make this my last Will and Testament, as follows to wit: Clause 1st. I give and bequeath unto my Sister Mrs Sarah C. Faust my negro woman Slave named Maria, with her future issue and increase; to have and to hold unto her, the said Mrs Sarah C. Faust, and the heirs of her body begotten, forever. But in case that she the said Mrs Sarah C. Faust, should leave no heirs of her body begotten, living at the time of her decease or in the event that any child or children which She the Said Mrs. Sarah C. Faust may leave at the time of her death, Should die before he, she, or they attain the age of twenty one years, or day of Marraage then and in that case it is my Will and desire that my said negro woman slave with her future issue and increase, shall descend unto my nephew Lorenzo Allston White, his Heirs, Executors Administrators and Assigns forever. 2d. I give and bequeath unto my nephew Augustus Brickell Faust, his heirs, Executors Administrators and Assigns forever, the Sum of Four hundred dollars, out of the monies arising from my Estate, to be put out at Interest, or appropriated to the purchase of a negro as to my Executors ( herein after mentioned) may seek most fit and advisable. 3d. I give and bequeath unto my nephew Lorenzo Allston White, his Heirs Executors and Assigns forever, the Sum of Three hundred dollars out of the Monies arising from my Estate, to be put out at Interest, or Appropriated to the purchase of a negro, as to my Executors (there in after mentioned) May seek most fit and advisable.- 4th. I give and bequeath unto my nephews Henry Bourquin Brickell, Edward Brickell White, and Alonzo James White, their Heirs, Executors, Administrators and Assigns forever, the Sum of One hundred dollars, each to be paid unto them and each of them with lawful interest when they respectively arrive at the age of twenty one years

5th. I give unto my neice Adeline Elizabeth White her heirs and assigns forever the Sum of One hundred Dollars to be paid (out of) the monies arising from my Estate with lawful interest when she arrives at the age of eighteen years, or day of marriage.

6th I give and bequeath unto my brother James Jeremiah Brickell White, a Silver cup of the value of Twenty dollars; to be purchased and presented to him as a token of my love and affection towards him. 7th I give unto my nephew William Augustus

Brickell the sum of One hundred dollars to purchase a watch as a testimony of my love and affection for him and to be kept in remembrance of me. -8th All the residue and remainder of the monies arising from my Estate after all the aforesaid Bequests have been paid be it more or less I give and bequeath unto my nephew Augustus Brickell Faust his heirs, Executors administrators and Assigns forever.- 9th And Lastly I hereby nominate and appoint William Augustus Brickell Esquire, and Gen. Jacob J. Faust

Executors of this my last Will and Testament and do hereby revoke all former Will and Testaments by me made. In witness whereof I have hereunto set my hand and seal this fourteenth day of March in the year of our Lord one thousand eight hundred and seventeen and in the forty first year of the Sovereignty and Independence of the United States of America.
