IN THE NAME OF GOD AMEN. I Micajah Hinton of Richland District State of South Carolina, sensible of the uncertainty of life, being weak and infirm in body, but of sound disposing mine and memory do make and publish this my last will and testament, in form and manner as follows,-----1. At my decease I desire my Executors hereafter named to dispose of my body as they may judge proper. 2. My landed estate consisting of about seven hundred and thirty seven acres, I give and bequeath to my Sister's children, by name John Neale, Sarah House, Elizabeth Neale, Nancy Neale, and Epsy Neale, It is my will and desire that my Nephew John Neale have twice as much as each of the above mentioned heirs, and that the remainder of the land be equally divided amongst the rest, namely, Sarah House, Elizabeth, Nancy and Epsy Neale. It is also my will and desire that the portion of my landed estate which I give to the female heirs, and all other property hereafter named which I may give them, belong to them and their lawful issue, and in case they should die without lawful issue the property is to belong to the other surviving heirs above mentioned, and be equally divided amongst them. #3 My personal property I desire to be disposed of in the following manner.-- The following negroes, namely, Phebe and her Son Charly, Selah and her children Cato, Bob and Joe, Leah and her Son Peter, and all their increase I give and bequeath to my Nephew William Hinton JUNR. his heirs and assigns forever. Further more it is my will and desire that my brother William Hinton receive a reasonable support during his natural life from the neat proceeds of the above named negroes,--- I give and bequeath two negroes, by name Aaron and Sue to my Sister Elizabeth Thompson in case she should die without lawful issue, I desire this property to be equally divided amongst the Neale family above mentioned. my Negroes, and also my stock of Horses, mules, Cattle and Hogs and all other disposable property which I may have at my death I give and bequeath to the Neale family above named John Neale to have twice as much as either of the rest, and the remainder to be equally divided amongst the other heirs, namely, Sarah House, Elizabeth, Nancy and Epsy Neale. 4 After my decease I desire my Executors to attend to the payment of all my just debts, and also to collect all demand which may be due to my Estate. 5 I nominate and appoint my friend Mr Robt. Weston and Mr. John G. Williams to be the Executors of this my last will and testament, hereby revoking all other wills heretofore by me made.--- Given under my hand and seal this twentsixth day of August in the year of our Lord one thousand eight hundred and twenty seven.
