That is to say,

1st. I give and devise to my son Adam Krederick Turnipseed one negro boy by the name of Squire.

2nd. I give and devise to my Son Reddick Washington Turnipseed one negro boy by the name of George.

3rd. I give and devise to my Daughter Susan Adaline Turnipseed one negro girl named Charlotte; for each of said negroes to be valued after my death and to be taken as part of their disrbutive share of my Estate.

4th. I give and devise to my Daughter Barbara one Trunk.

5th. I give and devise to my Daughter Susan Adaline one Trunk.

6th. I desire that the rest of my negroes and all of my other property to be sold after my death, and to be so divided among all my children so as for those, who were behind in their father's will to be put upon an equality with the rest; and then for the residue to be so divided as for all to share and share alike.

And lastly I do hereby nominate, constitute and appoint my two sons Henry and Levi T. Turnipseed executors of this my last will and Testament in writing whereunto I the said Nancy Turnipseed have set my Hand and Seal this sixteenth day of July in the year of our Lord 1840.
