Constitute this my Last Will and Testament in manner as here

James one dollar for this full Share out of My Estate 3rdly I  
give and Bequeath unto my Daughter Rachel one dollar for her  
full Share out of my Estate 4thly I give and Bequeath unto my  
Daughter Elizabeth one ~~dollar~~ for her full share out of my  
Estate fifthly I will and Bequeath that after my Decease my  
Executors do Immediately after paying the above said three dollars  
as above directed make a Division of the Remainder of my person  
all, Estate into three Equal Shares as near as possibly can  
be made and the one of which Said Shares I do give unto my Wife  
Dorens Faust for and during the time of her life and at her  
Decease It shall Descend unto my two sons Buckner and Samm el To  
be Equally Divided Betweet them Share and Share precisity and  
if any part of said Share should consist of Life Stock of which  
thero Might be any increase my will is that in such Case it  
shall Belong into my said two sons Last above named and be  
Equally divided betweet them at my said Wifes decease and Sixth-  
ly I give and Bequeath unto my two said Sons Buckner and Samuel  
all the whole Remainder of my Estate goods and Chattals Both  
Real and personal to be Equally Divided Betweet them share and  
Share Precisely Immediately after my Decease and I do hereby  
Nominate appoint and Constitute my Loveing Nephew Jasper Faust  
and my Loving Son Samuel Faust, Executors of this my Last Will  
and Testament and further do disapprove of all other Wills made
