SAMUEL ROWAN

September the 30th 1792 In the Name of God Amen I Samuel Rowan Planter of Camden District of Richland County in the State of South Carolina, being in my Perfect Mind Memory and Understanding. And Calling to Mind the Mortality of my Body Publish and Declare this my Last Will and Testament in Manner and Form Following Item. I do will and bequeath unto my two Daughters Mary & Agnes Rowane 300 acres of Land on White Branch in Andria Town Ship to be equally Divided into 150 Acres apiece likewise a full Furnished Feather Bed and Bed Cloaths to each of them, Item. I do bequeath unto my Daughter Mary Rowan two Cows and two Calfs and two head of Neat Cattle Item likewise to my Daughter Agnes two Cows & two Calfs & two head of Neat Cattle. Item, likewise I do bequeath my two Daughters 4 Sows a Piece and two Yews a Piece & three Pewter Plates a Pewter Dish and a Pewter Bason a piece & two Spinning Whells to be equally Divided between them both, Item I do bequeath unto my Son Samuel Rowan the Whole Plantation and Tract of Land that he is now residing on Containing 100 Acres. Item, I do bequeath unto my other 3 Children 100 acres Robert Rowane 125 $\frac{1}{2}$ Acres Joining Robert Thompson's Plantation Item, I do bequeath my Son James Rowan 125 $\frac{1}{2}$ Acres Joining his Brother Roberts, Item likewise my Son John Rowan 125 Acres Joining his Brothers in Said Tract of Land. Item -----

I do bequeath my Wife Mary Rowane all my other Property such as Cattle Hogs or Horses & House hold Furniture, While She remains a Widow over her Children, Item As Setting Case any thing happening my wife Such as God Almighty's Calling^{of} her of this Stage of Life the Property is to be equally Divided between my Children in General Item If it be please God to call me off of this Stage of life there is about 50 Lbs Sterling Money Due me to be laid out in Negro for the Support of my Wife & Family Item I do will and bequeath unto Reber Boulton 100 Acres of
