

The last will and Testament of Samuel McLevy of Columbia South Carolina. I do hereby constitute and appoint my friends John G. Brown D.J. McCord, Henry J. Nott, and Eli Kennerly my executors, and I do hereby revise and bequeath all my estate real and personal to the said Executors or to such of them as may qualify under the Will, their heirs executors. etc

My desire is that My said Executors to keep my property together, and to permit my friend Sclemon Davis to live in my house and carry on all my business as it is now done provided he will pay two hundred dollars per annum to satisfy a note I have on the Branch Bank, and then my other debts that I may leave; provided he take good care of my negro woman named Juliette, who with the said Solomon Davis I wish to enjoy my property or the income from it, during the life time of the said Juliette; but if the said Solomon Davis should misbehave himself, or conduct himself in such manner as to displease my executors, all provision made in his favor shall cease, at the will of a majority of my Executors who shall qualify, and he shall leave the place. I place all confidence in my friends for the execution of my wishes, which they fully understand. Upon the death of Juliette I devise and bequeath the whole of my estate to my said Executors as to such as shall qualify, to them in their own right, share and share a like to their heirs, Executors, administrators or assigns.

Levy of the town and State aforesaid, being in sound health and understanding do make this my last Will and Testament in manner and form following--First, I have no relations in this country and I conceive the first duty a man in this country owes, after his own family, is gratitude and kindness to his Servant, Juliette, a woman, I am anxious to make her the object of my bounty, as far as is consistent with the laws of the country I live in, which I have respected and always endeavored to obey, and having perfect confidence in Messrs. Henry J. Nott, James Gregg and D. J. McCord I do hereby constitute and appoint them my Executors of this my last Will and testament, and hereby revoke and cancel all other wills I have heretofore made.

Item, I do hereby give to my Said Executors H. J. Nott, James Gregg and D. J. McCord, ^{estate} ~~all my real and personal property~~, for the following purposed, Viz; That they permit the said Juliette during her life to go and do as she pleased, as though she was perfectly free, to work and labour for her own benefit, and at her own disposition, and that they do protect and advise her, as to them or survivor or survivors of them may deem meet and proper, and likewise that they pay over to her, and permit her to have and receive during her natural life all the profits, rents and incomes which may arise from my property, after paying the taxes. Item. After the death of the said Juliette, I do hereby give the rest and residue of my property real and personal to my executors the Said H. J. Nott, James Gregg and D. J. McCord, and their heirs, for their trouble in the execution of this my last Will and testament. In Witness whereof, I the Said Samuel M.
