

I Sameul Green of the Town of Columbia being of sound and disposing mind thanks be to God for the same do make and ordain this to be my last Will and Testament in manner and form following

Imprimis I wish all my jst debts to be paid as soon as may be convenient after my decease,-----

Item 2- I give devise and bequeath unto my beloved wife Selina Green all the property both real and personal which I have acquired or am entitled to by virtue of my intermarriage with her to her and her assigns and heirs forever,-----

Item 3- I give and bequeath unto my said wife one half acre Lot of Land including the Dwelling House 'I now live in with the out Buildings attached thereto. Also a negro man Slave named Abram and a negro Girl named Judy (DaughterOf Eliza) about Eleven or twelve years of age to her during the term of her natrual life, Also all my Household and Kitchen furniture of every discription , my Carriage Harness and pair of Horses one Gig and Harness to her during the term of her natural life and after her death, all the property contained in this Item is to be considered as belonging to the rest and residue of my Estate and to be appropriated as is therin directed,-----

Item 4th- I give and bequeath unto my Sister Elizabeth Green the annual sum of two hundred Dollars to be paid her yearly by my Executors so long as she may live,-----

Item 5- I allot and appropriate the annual sum of two hundred and fifty Dollars for the maintanance and support of Sarah Clark (the Daughter of my first wife) so long as she may live & which I request my Executors to expend and lay out for her comfort and convenience .-----

Item 6- I give and bequeath unto my Grand Nephew Samuel Green (Son of Frederick W. Green) the sum of two hundred Dollars to him and his heirs forever,-----

Item 7- I give and bequeath unto my Nephew Samuel Green (Son of William E. Green) the sum of two hundred Dollars to him and

his heirs forever.-----

Item 8- I give and bequeath unto my niece Martha Mitchel (Daughter of Timothy Green) the sum of two hundred Dollars to her and her heirs forever.-----

Item 9- I give devise and bequeath unto my Grand Son George W. E. Green the rest and residue of my Estate both real and personal to him and his heirs and assigns forever. to be paid to him when he becomes of lawful age and should it please the Almighty to take my said Grand Son out of exestance without his leaving lawful issue then and in such case the said rest and residue of my Estate both real and personal & I give devise and bequeath unto my said Grand Nephew Samuel Green (Son of Frederick W. Green) my said Nephew Samuel Green (Son of William E. Green and ~~my said Niece Martha Mitchel~~ (Daughter of Timothy Green) share and share alike to them and their heirs and assigns for ever.-----

Item 10- It is my will that my said Grand Son shall receive no portion of my Estate during his minority but that the income or profits thereof shall be kept at Interest by my Executors or expended in the purchase of Stock as may be deemed by them most advantageous --- my said Grand Son ~~being~~ owning other property fully sufficient for his maintenance and education .-----

Item 11- The three Legacies contained in the Sixth Seventh and eight Items of this my will are not to be payable before my Estate ~~is~~ clear of debts.-----

Lastly I do hereby appoint my Nephew Frederick W. Green and my Friend James S. Guignard Executors of this my last will and Testament hereby revoking all other will or wills by me at any time heretofore made declaring this and no other to be my last Witness my hand and Seal at Columbia this twenty fifth day of January in the year of our Lord one thousand eight hundred and thirty Seven.-----

It is my will that the whole of the said rest & residue of my
Estate both real and personal as is contained in the ninth Item
of my said will, shall be sold by my Executors at any time after
the gathering in of the Crops (planted or commenced planting in
my life time) upon such terms and at such time or times as
my Executors may deem proper and the proceeds or avails thereof
to be put at interest or laid out in the purchase of Stock
whenever my Executors may deem most beneficial to the Interest
of my said Grand Son--- and which is to be paid over and applied
in such manner as is particularly described and expressed in said
ninth Clause of my said Will.

Also being desirous that my Nephew Frederick W. Green should
not be at the trouble of obtaining Security or Indorsers upon
his Bonds or Notes to which I am already or to which I may
hereafter become Security for I do hereby will and direct that my
Estate shall be considered liable for the payment thereof in
the same degree that I am myself now liable for, say, in the

bound for, in the same manner or degree in which I myself am
