In the name of God Amen-- I Sarah Wyche Tucker of Richland District and State aforesaid, being sick and feeble in health, but of sound and disposing mind and memory, do make and publish this my last will and Testament, hereby revoking and making null and void all other Wills and Testaments, by me heretofore made-- First I commend my immortal being to Him who gave it, and my body to the earth, to be buried by my Executor as decency and propriety requires as to my Estate, real, personal or mixed of which I shall die seized and possessed or to which I shall be entitled at the time of my death, I devise, bequeath and dispose thereof in the manner, following To Wit-- My Will is that all my just debts and Funeral charges shall, by my Executor hereinafter named be paid out of my Estate as soon after my death as shall by them be found convenient--

Secondly-- I give, devise and bequeath to my Sister Mary Heath of the State of Georgia, widow of William Heath deceased, the following named negro Slaves, to wit- Henry Riley Harriet, Clarissa, Lavinia, Hall and Betsy- She the said Mary Heath paying in one year after she receives said negroes to my Brother Henry Taylor of the State of Georgia, the difference in value, between the value of the negroes before named and which I have herein given to the said Mary Heath, and the value of the negroes given to the said Henry Taylor in the next clause of my Will--and it is my will and desire that the Slaves Henry Riley, Harriet and their children be not seperated

Thirdly- I give, devise and bequeath to my brother Henry Taylor of the State of Georgia, a life Estate in the negroes Jane and Henry, and not subject to any restriction on the part of the said Henry Taylor, to devise the said negroes to any of his children--

Fourthly-- I give, devise and bequeath to my friend James D. Tradewell of the Town of Columbia and State of South Carolina, the following named negroes-Viz. Doll, Mary and Stephen in Trust, That is to say in trust for the use and benefit of Martha Wiggins (formerly Martha Russell) (my sister of and now residing in the State of Georgia, for her sole use and benefit during her natural life, and at her death to her son Robert Russell, whose name has been changed to that of Robert Taylor and to his heirs and assigns forever.

And it is further my will and desire that my Executor hereafter to be named shall take such steps in connection with the Trustee James D. Tradewell as will be necessary and proper to secure the said negroes Doll, Mary and Stephen to the said Robert Taylor after the life Estate in said negroes, in his Mother Martha Wiggins shall have determined--

Fifthly-- I give, devise and bequeath to Rebecca Vanwest, to her sole use and benefit free from any debt or incumbrances of her husband Walter Vanwest, one Bed and Furniture-- Also to Sarah Wyche Taylor daughter of my brother Henry Taylor one Bed and Furniture--

Sixthly-- I give devise and bequeath to my nephew Epictetus Heath my Horse and carriage, upon condition that he pay in one year after, to his brother William Heath fifty dollars and fifty dollars to his sister Emma Heath.

Sevently-- It is my will and desire that my Executor sell my negroe man Tom and the proceeds of said sale or so much as be necessary be applied as will make up the difference in value between the negroes, I have herein willed and devised, and the negroes falling to the heirs of my late Husband Richard W. Tucker.

Lastly- I nominate and appoint my Esteemed friend Thomas Heath, to be the Executor of this my last Will and Testament. In Testimony whereof I Sarah Wyche Tucker have to this my last Will and Testament (Contained on one sheet of paper)
